The project will fund the activities of an alliance between the Inter-American Development Bank (IDB), the World Bank, and the Development Bank of Latin America and the Caribbean (CAF) to generate knowledge on criminal violence in LAC, with a focus on the role of organized crime.

The main objective is to produce evidence to inform and shape the public policy debate and influence policymaking at the national, regional, and global levels. Through this alliance, we also aim to build stronger institutional capacities to better tackle

Under this alliance, the World Bank, IDB, and CAF will participate in the following activities:  - Financing and directly producing research to advance knowledge on criminal violence in LAC, with a focus on organized or reinancing and accompanying research teams and projects, preferably in collaboration with public authorities, to develop or enhance strategies for measuring criminal violence and organized crime and pilot interventions designed to prevent and mititate impacts.  -Facilitating meetings and sessions with policymakers, researchers, and other experts to identify areas critical for knowledge generation, generate consensus on diagnostics, and brainstorm about policy routes, and provide feedback on the research being conducted under this alliance.

The project benefits countries by funding research and developing new strategies, thereby informing effective policy-making. Dissemination activities will promote knowledge exchange and collaborative strategies among key stakeholders, strengthening regional approaches to combat crime.

The TC should be prioritized, however the amount would need to be adjusted to US\$400,000 as per internal discussions, organized crime has taken on a significant priority for the Administration, and therefore the activities to support the Bank's work in this area will be of utmost importance.
