#### II. Objectives and Justification of the TC

There is a wide consensus among academics, policy-makers, experts, and government officials that the field of crime and violence prevention in that Latin America and the Caribbean (LAC) faces a challenge with regards to quality, availability, and timeliness of information and knowledge. These factors reduce the effectiveness of citizen security policies. Therefore, a more accurate and timely access to the latest research findings, best practices and assessments that seek to strengthen the capacity of the different citizen security actors (Ministries, Police, Courts, Civil Society, crime-related social institutions) is critical for successful policy implementation.

Countries in the region are continuously demanding not only more channels for cooperation and dialogue on crime prevention issues, but also more systematic and effective ones.<sup>1</sup> A number of

regional forums developed over the last years have shown the increasing interest of governments to share their knowledge and experiences. One of the main lessons learned from those meetings is that the willingness to participate and exchange ideas rises when those activities are well-focused. The importance of consistent strategies which lead to disseminate findings and conclusions as well as keep network members engaged were essential for the success of the forums.

To close this gap, in addition to its regular lending and TC programs, the Bank has set in motion specific programs at the local, national, regional and international levels to update knowledge, exchange information, examine best practices, and encourage innovation.<sup>2</sup>

As a way to facilitate a more dynamic, systematic and actionable exchange of knowledge and experiences, since 2011 the Inter-American Development Bank (IDB) has partnered with the Inter-American Dialogue (IAD), to address current citizen security developments through the LAC region program of public forums and roundtables. Panelists have included high-profile academics and practitioners, including Rafael Fernández de Castro, leader of the forthcoming UNDP report on regional security; Primera Comisionada Aminta Granera, General Director of the National Police of Nicaragua; Eduardo Stein, who has served as Vice President and Foreign Minister of Guatemala; Angela Me, head of the UNODC statistics division; Rodrigo Guerrero, Mayor of Cali; Adrían Franco, Director of the INEGI, Mexico drug analyst Peter Reuter. Some of the topics that discussed were: a) policy responding to the expanding violence and criminality in Central America; b) 2013 UNDP LAC citizen security report in process; c) innovative community policing models and what the police is doing to confront challenges related to drug trafficking and violence in the country; among others. More than 120 people attended these forums and roundtables, including many of high profile in diplomacy, academia, and other international agencies (diplomats from countries in Central America, Canada, France, executives, experts from the World Bank, OAS, ONDCP, Brookings, INCAE, Partners of America, among others), journalists from international agencies, as well as officials and technicians from different areas of the IDB.

The roundtables and public forums had offered a unique venue to promote the exchange of experiences, knowledge and lessons learned which allow the capacity to identify the most important challenges in this area for the region. The IDB and the IAD have agreed to boost the dialogue and integrate it into a more structured and dynamic knowledge exchange agenda including discussion papers and other reports.

The objectives of this TC are to promote LAC governments' access to knowledge and lessons learned, to improve collaboration and sharing of best practices among public officials and between governments and civil society and the academia, to promote a better understanding of citizen security issues, and to increase the effectiveness of Bank's program.

This project fits into the framework of the Bank's Operational Guidelines for Program Design and Execution in the Area of Civic Coexistence and Public Safety (GN-2535) and the Citizen Security Conceptual Framework and Empirical Evidence (No. IDB-DP-232). Citizen security is one of the main areas of the Strategy for institutions for growth and social welfare (GN-2587). It was identified as a priority area that contributes to the objectives of the Bank's ninth capital increase(AB-2764).

As a first step towards a more defined and strategic dialogue, this TC will focus on the following elements: (i) bridging the knowledge gaps to support effective innovation and reforms in citizen security public management; (ii) strengthening consensus-building among relevant actors and institutions; and (iii) building a more technical and practical dialogue around issues of concern for LAC countries.

#### III. Description of activities/components and budget

**Component 1. Strengthening citizen security policy analysis.** The objective of this component is to contribute to the generation of new policy analysis and identify new proposals and ideas on citizen security related issues, by organizing five Washington-based roundtables. The roundtables would continue the successful series of exchanges among Washington-based experts, which the IAD and the IDB have been sponsoring within the past year. Each meeting will deal with a specific issue related to citizen security, with discussions leaders drawn from diverse professional backgrounds. The debates will enrich the IDB's and the IAD's analytical and operational agenda in LAC. Participants will be citizen security experts, policy makers, public officials, academics, civil society and multilateral institutions representatives from LAC and the U.S. located in or visiting Washington DC. In addition, public officials from LAC that are not in DC can participants in each roundtable. This component will finance: a consultant for logistical support; logistics (catering, audiovisuals, among others); and the participation of the experts (airline tickets and per diem).

**Component 2. Fostering leadership and dialogue**. The purpose of this component is to foster collaboration and knowledge sharing among Chiefs of Police, Public Prosecutors and other public officials in charge of citizen security initiatives, through the organization of two regional conferences (two-day conferences). Building on a successful meeting in Uruguay in 2011, the first conference would be held in Lima or another LAC city leading innovative challenges in citizen security prevention, in April or May 2013, and a second in October or November 2013 with a site to be selected, likely in, Mexico, Central America, or Brazil. The overarching theme of both conferences would be the institutional requirements for a successful response to citizen security challenges—including attention to the role of police and other security forces, judicial and prison systems, social policies (particularly those directed toward youth), accountability of citizen security policies, the economy of the crime, as well as the role of mass media and regional and international cooperation

on these issues. One of the regional conferences would discuss the challenges on these matters faced by local and sub-national governments along the region. Each conference would have a different focus on the main theme, to be determined in agreement with the host country, city, and would give particular emphasis to the challenges confronting the host country and the lessons that can be drawn from its experience. Highly recognized experts, scholars, top senior officials will be called to motivate the discussion, and draw conclusions as well. It is expected to count on approximately 80 participants in each regional conference. This component will finance: a consultant for logistical support; logistics (translation, catering, audiovisuals, among others); and the participation of the experts and participants (approximately 43).

Component 3. Supporting knowledge generation and dissemination. The objective of this component is to gather, consolidate, deepen and systematize knowledge and information generated through the second component of the program. Activities under this component are: (i) preparation of two discussion papers and two policy briefs. We would seek to identify and recruit the best experts in this hemisphere and beyond to draft the papers and memoranda. These will not be research papers but will draw on the best research being done, and make it useful for policy discussions and decision-making. Some specific issues that are being considered for exploration include public-private partnerships to combat crime and violence, violence against women, the role of technology in security, secure communities programs, the economy of the crime, and the relationship between media and crime and violence; and (ii) external dissemination of results, products and advances of the program. Policy briefs and discussion papers will be distributed in printed and electronic format to all relevant authorities in the Bank borrowing member countries. All knowledge and information will be disseminated through the IDB and the IAD website and will be shared during the regional conferences including the citizen security clinics and the Regional Policy Dialogue, among others. The project team will also work with the Bank's KNL office to systematize and disseminate knowledge products, as well as, the EXR team to promote events through press releases, Infolinks and other media instruments and ORP to generate new strategic partnerships. This component will finance: a consultant for report writing and complete the final edition and translation.

The expected results are: (i) better citizen security policy analysis through the organization of five roundtables; (ii) stronger collaboration and best practices sharing among public officials in charge of citizen security initiatives; and (iii) better knowledge and understanding on citizen security topics through the development and dissemination of discussion papers and policy briefs.

Main outputs: (i) five roundtable meetings with experts; (ii) two regional conferences; and (iii) two discussion papers and two policy briefs prepared for the above-mentioned events.

#### IV. Executing agency and execution structure

This TC will be executed by the Bank. As was mentioned in point III, during 2011 and 2012 the Bank has successfully organized a series of roundtables and forums with the IAD. For this reason, the IAD will support the Bank in the selection of the experts and consultants for the preparation of the publications. Taking into account the IAD's network on these issues, the IAD will support the Bank in the dissemination process of the roundtables and regional conferences.

The Bank has been selected as an Executing Agency due to the following reasons: a) this TC is under the framework of the new Bank policy on technical cooperation (GN-2470-2) which states that the Bank may carry out TC activities through the development of NFPs that benefit internal Bank constituencies and, at the same time, enable the Bank to provide improved support to the borrowing countries; b) scale up current initiatives from the citizen security cluster including events and activities; c) cost savings (no overhead for the Executing Agency); and d) no need to increase technical capacity of any other public agency of the region.

#### V. Major issues

There is a low risk of political controversies between LAC beneficiary countries and some institutions and guests. It will be mitigated by designing the events in consultation with the directly involved

countries including the EXD of the IDB. Another could be the lack of participation from borrowing countries in the activities designed. However, this risk is minimal as the relationship between the Bank and its borrowing countries practically guarantees participation in the planned events, and there is an increasing demand for knowledge and information about these topics and lack of resources to support and promote the technical and political dialogue needed to share experiences.

Highly recognized academicians and practitioners, including Rafael Fernández de Castro, leader of the forthcoming UNDP report on regional security; Primera Comisionada Aminta Granera, General Director of the National Police of Nicaragua; Eduardo Stein, who has served as Vice President and Foreign Minister of Guatemala; Angela Me, head of the UNODC statistics division, and drug analyst Peter Reuter, have participated as speakers. Some of the topics that were discussed are: a) policy responded to the expanding violence and criminality in Central America; b) UNDP citizen security report in process of informe sobre seguridad ciudadana que está preparando el PNUD para la región bajo su coordinación; c) innovative community policing models and what the police are doing to confront challenges related to drug trafficking and violence in the country; etc. More than 120 people attended these forums and roundtables, including many of high profile in diplomacy, academia, and other international agencies (diplomats from countries in Central America, Canada, France, executives, experts from the World Bank, OAS, ONDCP, Brookings, INCAE, Partners of America, among others), journalists from international agencies, as well as officials and technicians from different areas of the Bank.
- 1.3 The roundtables and public forums had offered a unique venue to promote the exchange of experiences, knowledge and lessons learned and allowed us to identify the most

important challenges for the region in this area. The IDB and the IAD have agreed to boost the dialogue and integrate it into a more structured and dynamic knowledge exchange agenda.

- 1.4 As a first step towards a more defined and strategic dialogue, this technical cooperation will focus on the following elements: (i) bridging the knowledge gaps to support effective innovation and reforms in citizen security management; (ii) strengthening consensus-building among relevant actors and institutions; (iii) building a more technical and practical dialogue around issues of main concern for LAC countries.
- 1.5 The objective of this Technical Cooperation is to improve access to knowledge and lessons learned, and promote a better understanding of citizen security issues to enhance government capabilities and transform the relationship between citizens and the State.
- 1.6 This project is under the framework of the Bank's Operational Guidelines for Program Design and Execution in the Area of Civic Coexistence and Public Safety (IDB Document GN-2535) and the Citizen Security Conceptual Framework and Empirical Evidence . Citizen security is one of the main areas of the Strategy for institutions for growth and social welfare (IDB Document GN-2587). Finally, it was identified as a priority area that contributes to the objectives of the Bank's ninth capital increase, GCI-9 (Document of the Board of Directors AB-2764).
