Implementation Status Overview

- 1. This ISR records progress status of the following two associated projects sharing the same identification "P" number 103922: (a) GEF grant TF96330-RY for the Agro-biodiversity and Climate Adaptation Project (ACAP) and (b) the JSDF grant TF098754 for the Piloting Coping Strategies for Rainfed Farmers.
- 2. This ISR update is based on the outcome of the supervision mission conducted in Sana'a from April 4 11, 2013, and updates on progress with key next-steps agreed upon. Since

the previous ISR of January 2013, the project has experienced further implementation delays due in large part to changes in personnel in the new unit coordinating the implementation of both grants and which is the Project Support Unit (PSU) of the Rainfed Agriculture and Livestock Project (RALP) at the Ministry of Agriculture (MAI). As a result, overall implementation progress in recent months has much slower and much more limited than planned. Most recent progress has been with activities related to community investments for water harvesting and storage facilities, rehabilitation of terraces and soil conservation, and the advancement of procurement processes to purchase equipment in support of the development of climate-resilient profiles of selected landraces with AREA (Agricultural Research and Extension Authority) and of improved climate database with

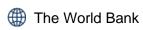
3. With various new recruitments of needed replacement or additional staff well underway since April 2013, to strengthen its capacity, the MAI/PSU is confident that the pace of implementation will increase significantly in the coming months and should allow to make up for most of the delays accumulated.





Key Decisions Regarding Implementation

1. The process of amending the Grant agreements to formalize the new implementation arrangement through the MAI/PSU is well underway (see level two restructuring packages attached). The final approval of these amendments by the Yemeni Government is expected before the end of July 2013. The amendment of the GEF agreement for ACAP will also include the following: (a) adjustment of its financing plan to take into account the closing of the PHRD/CCIG Grant; (b) rescheduling of its midterm review (MTR) date from August 31, 2012 to March 31, 2014, (since the MTR did not take place as originally scheduled in the grant because of the relatively incipient stage of implementation due to severe start-up delays associated with the socio-political events of late 2010 and 2011); and (c) introduction of the modality of "individual Consultant" as a procurement method to access consultant services needed to strengthen the capacity of MAI/PSU to handle effectively the additional implementation responsibility of ACAP.

2. Nevertheless, completing these amendment processes is not preventing the MAI-PSU from moving forward with the implementation of key activities of these two projects.
