Dear Minister Khaduri:

Subject: Loan No. 2749-GEO(SF): Urban Services Improvement Investment Program, Project 1 – Amendment No. 3 to Loan Agreement

- 1. We refer to the Loan Agreement dated 10 May 2011 between Georgia ("Borrower") and the Asian Development Bank ("ADB") for the Urban Services Improvement Investment Program-Project 1 (as amended, the "Loan Agreement"). All capitalized terms used but not defined herein shall have the meaning given thereto in the Loan Agreement, unless the context requires otherwise.
- 2. In response to a letter from the Ministry of Finance dated 18 May 2016, ADB approved, on 25 August 2016, a change in scope of Project 1 of the Urban Services Improvement Investment Program to include the financing of water supply works in Abasha town and a reallocation of the loan proceeds to facilitate such financing. To reflect these changes, we propose to amend the Loan Agreement as set forth below:
 - (a) Sub-paragraph 2(a) of Schedule 1 shall be amended to read as follows:
 - "(a) construction of water supply facilities, water treatment facilities and water transmission systems in the towns of Abasha, Anaklia, Kutaisi, Mestia, Poti and Ureki and procurement of the water supply and sanitation system maintenance vehicles and equipment."
 - (b) The Allocation and Withdrawal of Loan Proceeds Table set out in the Attachment to Schedule 3 of the Loan Agreement shall be deleted and replaced by the table attached to this letter agreement.
- 3. Save and except to the extent set out above, the Loan Agreement remains unchanged.

- 4. Pursuant to ADB's Public Communications Policy ("PCP") on disclosure and exchange of information, the amendments to the Loan Agreement will be posted on ADB's website within 2 weeks from the date that the amendments become effective, after removing any information that falls within the PCP exceptions as specified by the Borrower.
- 5. Please indicate the Borrower's concurrence to the amendments set out in paragraph 2 of this letter agreement by countersigning each of the two originals of this letter agreement in the space indicated below. Please retain one signed original of this letter agreement for your records and return the other to ADB.
- 6. The proposed amendments shall take effect on the date of receipt by ADB of notification of the Government of Georgia on the fulfillment of all legal procedures necessary for its entry into force.
