Dear Minister Khaduri:

Subject: Loan No. 2749-GEO(SF): Urban Services Improvement Investment Program - Project 1 - Amendment No. 2 to Loan Agreement

- We refer to the Loan Agreement dated 10 May 2011 between Georgia ("Borrower") and the Asian Development Bank ("ADB") for the Urban Services Improvement Investment Program-Project 1 (as amended pursuant to the amendment letter dated 7 November 2012, the "Loan Agreement"). All capitalized terms used but not defined herein shall have the meaning given thereto in the Loan Agreement, unless the context requires otherwise.
- 2. In response to the letter of the Ministry of Regional Development and Infrastructure dated 21 June 2013, ADB approved, on 14 November 2013, a change in scope of Project 1 of the Urban Sector Services Improvement Investment Program to include the financing of water supply and sanitation works in Ureki town and a reallocation of the loan proceeds to facilitate such financing. To reflect these changes, we propose to amend the Loan Agreement as set forth below:
 - In Section 3.01(a), reference to "(SDR47,611,961)" shall be replaced with "(SDR49,559,548)".
 - "(SDR823,041)" In Section 3.02, reference to shall replaced with "(SDR414,554)".
 - (c) Sub-paragraph 2(a) of Schedule 1 shall be amended to read as follows:
 - "(a) construction of water supply facilities, water treatment facilities and water transmission systems in the towns of Anaklia, Kutaisi, Mestia, Poti and Ureki and procurement of the water supply and sanitation system maintenance vehicles and equipment."
 - The Allocation and Withdrawal of Loan Proceeds Table set out in the Attachment to Schedule 3 of the Loan Agreement shall be deleted and replaced by the table attached to this letter agreement.

3. Save and except to the extent set out above, the Loan Agreement remains unchanged.
