# Implementation Status Overview

Construction works gained vigor in the period since March 2011. This has resulted in 93 percent progress on the Tabanovce-Kumanovo Road (TKR), a progress still inadequate to meet the June completion date. The works on the Blace border crossing point (Blace BCP) have suffered from adverse weather conditions and stand at 52 percent completion as of end June 2011. The Bank agreed to the Government request for project closing date extension by six months to March 31, 2012 to allow completion of all project activities and to enable the project to fully meet the development objective.


