

Implementation Status and Key Decisions

Progress towards achieving the Project Development Objective has been slow since grant agreement effectiveness. Ultimate achievement of the Development Objective could still be attained if the streamlined social and environmental safeguards review procedures, commensurate to the risk within the project, and the increase of the ceiling for community works translate in faster, more effective implementation. The Project Development Objective is to support poor and vulnerable communities in the Kakheti and Imereti regions to start/grow micro/small businesses in cultural industries and to valorize cultural heritage sites and thereby generate employment and increase household incomes. The grant aims to do so by helping beneficiaries to: (i) start/grow 500 micro, small, and medium-sized enterprises in the tourism sector, and (ii) implement up to 35 community projects





in the vicinity of cultural heritage sites. These activities are supported by technical assistance (TA), namely an integrated Tourism Market and Gender Assessment for the project areas, and capacity building for entrepreneurs and community workers. Lastly, project management and monitoring and evaluation (M&E) are progressing well.


