Implementation Status and Key Decisions

This is the initial ISR for the project. The Project was approved by the World Bank's Board on September 18, 2015, and was launched in Madagascar during the same week by the Minister of Population, Social Protection and Promotion of Women, and the World Bank team. The Financing Agreement has been counter-signed by the Government on November 13, 2015 but effectiveness has not yet been declared pending approval by Parliament and provision of the legal opinion. The team will closely follow up on these final steps toward effectiveness. First payments to beneficiaries under the safety net component 1 will be made in January 2016 - if the project has become effective and the funds have been disbursed by the Bank.

The Ministry is in the process of nominating a Coordinator for component 3 in accordance with Bank guidelines. The Minister indicated that they have identified various suitable candidates.

Finally, the country's first National Social Protection Policy has been validated by the public and approved by Cabinet in mid-September, which is a big step towards the development of a more coherent and coordinated effort to establish a basic social safety net.


