Description	The proposed regional knowledge and support technical assistance (TA) will support the Greater Mekong Railway Association (GMRA) in accelerating the development of rail connections among the Greater Mekong Subregion (GMS) countries by: (i) improving the organizational structure of the GMRA; (ii) preparing an operational readiness plan to ensure appropriate standards for technology on safety, productivity and environmental quality of railway operations; (iii) updating the GMS railway strategy for development of missing cross-border railway links and associated domestic connections; (iv) updating the Mekong (Sub-) Regional Transport Model (MRTM) prepared under Connecting the Railways of the Greater Mekong Subregion, and enhancing the capacity to utilize it effectively; and (v) identifying bankable railway projects in GMS countries.
Project Rationale and Linkage to Country/Regional Strategy	The GMRA seeks to accelerate railway connectivity by promoting efficient, safe, reliable and environmentally sustainable rail transport of goods and people within and beyond the GMS. Three Working Groups have been created to assist in the future sustainability of the GMRA: (i) Network Connectivity; (ii) Network Integration and Interoperability; and (iii) Partnership and GMRA Operations. TA 8748-REG, a previous ADB technical assistance, helped to prepare and finalize the Framework for Cross-Border Railway Transport Connectivity Agreement (CBRTCA) in the GMS.
