CONSULTANCY SERVICES FOR BASELINE DATA COLLECTION AND MONITORING OF THE IMPLEMENTATION OF ENVIRONMENTAL AND SOCIAL MANAGEMENT PLAN (ESMP), AND RESETTLEMENT ACTION PLAN (RAP) FOR THE CONSTRUCTION OF DODOMA CITY OUTER RING ROAD (110.2 KM)

1. The Government of the United Republic of Tanzania has received financing from the African Development Bank (AfDB) and the African Growing Together Fund (AGTF) and intends to apply part of the proceeds of the loans for eligible payments for consulting services for Baseline Data Collection and Monitoring of the Implementation of Environmental And Social Management Plan (ESMP) and Resettlement Action Plan (RAP) for the Construction of Dodoma City Outer Ring Road (110.2 Km).
2. The services included under this assignment are:
 - (a) To undertake environmental and social-economic baseline studies and data collection and prepare a detailed pre-project situational analysis;
 - (b) To monitor implementation of the approved Environmental and Social Management Plan (ESMP);
 - (c) To monitor implementation of the approved Resettlement Action Plan (RAP);
 - (d) To undertake external evaluation on the performance of approved ESMP and RAP; and
 - (e) To undertake capacity building in natural resources conservation and assist communities in the development of land use plans.

The duration of the assignment is 48 months.

3. The Tanzania National Roads Agency (TANROADS) an Executive Agency of the Ministry of Works, Transport and Communication now invites eligible Consultants to express their interest in providing the above mentioned services. Interested Consultants must provide information indicating their qualifications for performing the services. Such information may include brochures, description of assignments of similar nature in the last 10 years, experience in similar conditions, availability of appropriate managerial and technical skills among staff related to the assignment, etc. For each completed project, the Consultant shall provide the name and address of the Client, start and completed dates, name(s) of lead and associate firms. Cited projects with insufficient information will not be considered. Consultants may joint-ventures to enhance their chances of qualification.
