Implementation Status and Key Decisions

The project is approved by the Bank's Board on December 8, 2015 and got effective on March 17, 2016. Project Implementation has started. Improving Flood Risk Management: A total budget of USD 100 million has been allocated for the subcomponents; Reinforcement of flood control infrastructure (USD 95 Million); Support to strengthen Institutional Capacity to manage flood risks (USD 5 million).

- 1. Administrative approval for embankment strengthening Package 2-4 was received valued at about \$70 millio.
- 2. DPRs have been prepared and technical details are being worked out
- 3. For procurement of 2 dredgers specifications have been drafted and clearance has been sought from Inland Waterways Authority.
- 4. Contract has been awarded for the preparation of the DPR for the Centre of Excellence for Research and Development and design preparation will be complete by June 2016.
- 5. Bidding document for Real Time Data Acquisition System for Bagmati and Kosi Basin are being prepared Enhancing Agricultural Productivity and Competitiveness: A total of USD 76.5 million has been allocated to three sub-components; Intensification of Diversification of Agricultural Production Systems (USD 40 million); Strengthening of Agricultural Value Chains (USD 24.5 million) and Institutional Development for market-led Extension (USD 12 million)
- 6. The HR structure/ personnel to be hired has been prepared by the Department of Agriculture and approved by the executive committee.
- 7. The Animal Husbandry & Fisheries Resources Department has also prepared staffing plan that needs to be cleared by the executive committee
- 8. Staff appointments need to be initiated

Augmenting Connectivity: This component includes Roads of value USD 83 million and bridges of value USD 90 million.

- 9. Of the total of 25 packages under the Roads sub-component Technical Evaluation Reports (TER) have been submitted for 13 packages, Combined Evaluation Reports (CER) were submitted for 7 of which No Objection has been given for 4 packages, and for 3 packages CERs are under modification. 5 packages are to be retendered.
- 10. Out of the total of 41 packages under the Bridges sub-component the CER for all packages has been prepared, work has been awarded in 22 packages and retendering is under progress in 19 packages.
