Explanation

RVP clearance was obtained for this waiver at the time of project preparation. In accordance with Paragraph 12 (a) of OP 10.00, the deadline for disclosure of social and environmental safeguards instruments is deferred to 6 months after the project Effectiveness date. At the time of this proposed restructuring, these documents have been completed, cleared and disclosed.

A. Summary of Proposed Changes

The objective of the proposed restructuring is to amend the financing structure for the project's Sub-Component 1.2 on School Health and Hygiene to allow for the utilization of the grant from the Ebola Reconstruction and Recovery Trust Fund (ERRTF) before other funds; to extend the closing date of the ERRTF grant by one month from May 15, 2016 to June 15, 2016; and to revise the two intermediate results indicators for Sub-Component 1.2 due to insufficient time to implement civil works before the ERRTF grant closing date. As it relates to the financing of Sub-Component 1.2: the proposed restructuring will raise the financing percentage for the ERRTF grant from 18% to 100% until the grant is fully utilized or closed. During this time, the financing percentage for the grants from the Global Partnership for Education (GPE), the French Development Agency (AFD) and UNICEF for this Sub-Component (corresponding to the GPE grant's disbursement Category 2) will be 0%. Subsequently, the financing of the remainder of Sub-Component 1.2 (Category 2) will be as follows: 74% GPE, 24% AFD, and 2% UNICEF. The proposed changes in the results framework reflect a re-balancing of activities, as requested by the recipient and technically endorsed by the pooled fund partners. The proposed changes will allow for the utilization of the ERRTF grant in support of the objective of improving health and hygiene standards in primary schools. The closing date for the GPE grant and thus for the project is not affected by these proposed changes.

B. Project Status

The Guinea Pooled Fund for Basic Education recently became effective on October 19, 2015 and overall implementation progress is Satisfactory. The project encompasses four sources of funding, including the two grants managed by the World Bank (ERRTF and GPE), a grant from the French Development Agency, and a grant from UNICEF. The funding from the ERRTF has a much earlier closing date than the GPE grant and thus of the project. But the ERRTF funds are allocated in full to financing a specific subcomponent of the project, that was intended to be implemented early in the project's lifetime. With the proposed changes, the project objectives continue to be achievable, but a small change in the intermediate indicators is needed.

Development Objectives/Results

Project Development Objectives

Original PDO

The Project Development Objectives are to (i) improve access and learning in basic education and literacy of under-served populations, (ii) strengthen the Ministry of Pre-University Education and Literacy's capacity in evidence-based management, and (iii) support the implementation of the Education sector's short-term Ebola strategic response plan.

Change in Project's Development Objectives

Change in Results Framework

Explanation:

Due to the delay in completing the preparation of the Pooled Fund, there is insufficient time left to carry out civil works before the ERRTF grant closing. In line with the recommendations of Guinea's Ebola strategic response plan and with the technical endorsement of the partners, the MEPU-A has therefore requested a re-weighting of activities financed under Sub-Component 1.2, reducing slightly the scope of the civil works while increasing the amount allocated to the acquisition of hand-washing kits for primary

schools, but still within the objective of improving health and hygiene standards of the primary school environment. This change requires a revision in the intermediate indicators of the results framework as follow: 1) the number of standalone latrines built by project interventions will be reduced from 284 to 233, and 2) the number of standalone water points will be reduced from 466 to 403.

Financing

Change in Loan Closing Date(s)

Explanation:

An extension of one month has been granted for the ERRTF grant from May 15 2016 to June 15 2016 to allow for the completion of activities and withdrawal of funds. This change does not affect the closing date of the GPE grant or of the project as a whole.

Reallocations

Explanation:

The proposed changes to the disbursement table affect only the distribution of disbursement percentages across funding sources, and only for one specific sub-component. These changes will in fact simplify the management of the pooled fund for the Client, as the financing percentages will be the same (74% GPE, 24% AFD, and 2% UNICEF) for all sub-components and activities once the ERRTF grant is closed. There is no re-allocation across categories.
