**Tanzania: Advance Agreement for Preparation of Proposed Southern Agricultural Growth
Corridor of Tanzania (SAGCOT) Investment Project
Project Preparation Advance No. Q787-TZ
Amendment No. 1 to the Advance Agreement**

We refer to the Advance Agreement (“Agreement”), dated September 23, 2011, between the United Republic of Tanzania (“Recipient”) and the International Development Association (“World Bank”) for the above mentioned Project Preparation Advance (“Advance”).

We also refer to a letter from Ramadhani M. Khijjah, Permanent Secretary, Ministry of Finance, United Republic of Tanzania, dated July 4, 2012, requesting the World Bank to amend the Agreement by changing the implementing agency of the Advance from Ministry of Finance to the Prime Minister’s Office, United Republic of Tanzania.

We are pleased to inform you that the World Bank agrees to this request and proposes to amend Section 2.02 of the Annex to the Agreement as follows:

“2.02. Execution of the Activities Generally. The Recipient declares its commitment to the objectives of the Activities. To this end, the Recipient shall carry out the activities through the Prime Minister’s Office in accordance with the provisions of: (a) Article II of the Standard Conditions; (b) this Article II; and (c) the “Guidelines on Preventing and Combating Fraud and Corruption in Projects Financed by IBRD Loans and IDA Credits and Grants”, dated October 15, 2006 and revised in January 2011.”

In all respects, other than as set forth above, the provisions of the Agreement shall continue to apply with full force and effect.

Please confirm your agreement to the above by signing, dating and returning to us the enclosed copy of this amendment letter. Upon receipt by the World Bank of a copy of the countersigned amendment letter, this amendment letter will become effective as of the date of countersignature.
