## Implementation Status and Key Decisions

Since effectiveness, on May 7, 2015, the activities carried out by the project have helped nearly 80,000 youth program participants in receiving labor orientation, training courses, on the job training experiences and job placement.

The Project has disbursed US\$ 121.7 million (29% of the total Loan) corresponding to the Stipends Category (2), direct payment to youth participants, and training and labor orientation courses fees (Category 4).

After delays, the agreement with the National General Audit for the three audits of the Project has been signed in February 2016, complying with the requirement established in the Loan Agreement.


