



Implementation Status and Key Decisions

Although the project has not yet carried out any field activities and investments, the project implementation has accelerated since April 2016. The annual work plan for 2016/17 was prepared and approved, the procurement of a firm for feasibility study and detailed design of irrigation is at the stage of receiving proposals from the short-listed firms, the PMU is under establishment, and the project designated account was opened. The guidelines for land surveys are under preparation, and the procurement plan was updated to reflect the needs of implementing departments in accordance with the annual work plan. The implementation of Component 2 selected activities and the preparations for civil works under Component 1 will be accelerated in the upcoming months.



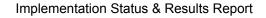


