Expressions of Interest

The Government of Guyana has received financing from the Inter- American Development Bank (IDB), towards the cost of Road Network Upgrade and Expansion Program (LO- 2741/BL-GY) and intends to apply part of the proceeds for consulting Services.

The consulting services ("the Services") include supervision services for (1) Vehicle Overhead Crossing at Diamond and East Bank Demerara Public Road Intersection, (2) Four Pedestrian Overhead Crossing located in Houston, Eccles, Peters Hall and Diamond and (3) Parking Lot at Diamond. The estimated implementation period is **Ten (10) months** and the budget for Supervision Services is **US\$ 500,000**.

The Ministry of Public Infrastructure now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. Requests for Proposals from Shortlisted Consultants is expected to be made by **April 11, 2016**. A Consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method set out in the Consultant Policies.
