The Inter-American Development Bank (IDB) intends to finance *Supervision Services for East Bank Berbice Road Project* under the *Loan Contract No. 2741/BL-GY Road Network Upgrade and Expansion Program*.

The scope of the civil works include upgrading of the East Bank Berbice Road from Stanleytown to Everton approximately 5km, to accommodate widened travel lanes, and shared bicycle/pedestrian lanes, with minor geometric improvements to the road alignment. The Works will involve construction of hard surface bicycle/pedestrian lane, reconstruction of the main carriageway with regularized lane widths, constructing embankments, constructing new road bridges and culverts, traffic signage and road markings and other associated miscellaneous civil works.

The total supervision period will be *eighteen (18) months* of which two (2) is for Constructability Review, fourteen (14) months for Construction Supervision and two (2) months for submission of the Project Completion Reports. The Contractor is also required to work on two 8 1/2 hours work shift for at least 50% of the construction period, and as such the consultant will be required to provide all staff to supervise these works during the night shift period.

The Works Services Group now invites eligible consultants to indicate their interest in providing the services. Interested consultants must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Consultants may associate to enhance their qualifications.

Consultants will be selected in accordance with the procedures set out in the current edition of the Inter-American Development Bank's Guidelines: "*Policies for the Selection and Contracting of Consultants Financed By the Inter-American Development Bank*"-GN-2350-9.
