

## **Implementation Status Overview**

This ISR covers the main findings, results, and issues and actions of a supervision mission to Moldova from June 18-22, 2012.

- -The GeT Project became effective on September 29, 2011 and is currently in its second year of implementation.
- -e-Criminal Record service and G2C portal were launched; the remaining 3 e-Services are nearing completion;
- -M-Cloud Phase 1 is in advanced phase scheduled for completion in December, 2012.
- Two enabling platforms are being developed using PPP approach: electronic mobile ID and electronic Payment Gateway; electronic mobile ID was launched in September; electronic payment gateway was successfully piloted

- Moldova E-Government Center is fully operational;
- CIO and CTO counsels and various thematic working groups were created and currently operate;
- A range of policy and strategy documents for various activities and components were implemented under the e-Transformation umbrella by the EGC and its partner entities elaborated (some of them already under implementation);
- Open Government Data Platform was created and datasets made public;
- Moldova's Open Government Action Plan was approved and Moldova adhered to Open Government Partnership;
- Program of Interoperability Framework was developed and now is under consultation process;



## **Key Decisions Regarding Implementation**

The Government agreed to the following actions:

- Accelerate the process of hiring a new full-time procurement specialist to speed up procurement processes
- Prioritized during the next six months: Subcomponent 2.1: M-Cloud: Shared e-Government Infrastructure and Subcomponent 2.2: e-Services Development.
- Complete all activities under M-Cloud Phase 1 by end-December 2012.
- Appointment of a Deputy Director to the eGC and preparation of a business plan to ensure the sustainability of eGC operations after project completion.

The Bank agreed to the following actions:

- Initiate dialog with donors regarding possible contribution prior to closing of the Dutch TF
