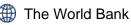

Implementation Status Overview

This ISR covers the main findings, results, and issues and actions of a supervision mission to Moldova from October 24-November 4, 2011.

- The GeT Project became effective on September 29, 2011. The Client undertook all necessary steps for meeting the 3 effectiveness conditions before the deadline
- Several major tenders are completed (e.g. G2C Portal and first 4 e-Services) or in advanced phase (M-Cloud Phase 1). The delivery of the outputs of these activities is expected in the first half of 2012.
- Two enabling platforms are being developed using PPP approach: electronic mobile ID and electronic Payment Gateway.
- Strengthened commitment to Open Government: Open Data initiative continues to evolve dynamically, having led to the publication online of 155 data sets from 20 agencies



(http://data.gov.md), as of December 2011. The Open Data portal has had about 16,000 visitors and almost 23,000 downloads in less than a year since its launch on April 15, 2011.

- Based on official request from Mr. Bodiu, a PPIAF Grant proposal for M-Cloud PPP Feasibility Study was submitted and approved.

- E-Leadership knowledge exchange was completed with the Dec. 14 Global Dialogue on Opening up Development between Moldova, Macedonia, Kenya and 7 other countries funded by the Bank's South-South Knowledge Exchange Facility. A new knowledge exchange on Open Government also funded by the South-South Knowledge Exchange Facility is currently being prepared by the Bank team to be launched in January 2012 with Macedonia, Brazil and other countries, and Moldova will be a knowledge-providing country for this exchange.



Key Decisions Regarding Implementation

The Government agreed to the following actions:

- Accelerate the process of hiring a new full-time procurement specialist to speed up procurement processes, and immediately hire a procurement adviser to temporarily fill in the gap.
- Draft TOR and launch the selection of the ICT Competitiveness Coordinator, a consultant who will be working closely with the Ministry of ICT.
- Accelerate procurement of PPA Audit contract so that GC can finalize the audit of the PPA funds and submit the audit report to the Bank by March 31, 2012.

The Bank agreed to the following actions:

- Deliver a training course on Bank procurement policies and procedures with particular focus on evaluation procedures in order to strengthen the capacities of the Evaluation Committee members.
- Allocate resources for piloting a "killer app" related to Open Data/BOOST and preparing apps development events as part of broader open data "ecosystem".
- Secure co-financing M-Cloud PPP feasibility study and open government data innovations ecosystem.
