For the purpose of Request for Bids (Open-National) the following shall apply:

a. Post bidding negotiations shall not be allowed with the lowest evaluated or any other bidder; b. Bids should be submitted and opened in public in one location immediately after the deadline for submission;

c. Lottery in award of contracts shall not be allowed;

d. Bidders' qualification/experience requirement shall be mandatory;

e. Bids shall not be invited or rejected on the basis of percentage above or below the estimated cost.
