## EXECUTIVE SUMMARY

### ES 1: Background of the Project

1. National Highway Authority (NHA) is currently implementing the two major road sector projects that include National Trade Corridor Highway Improvement Program (NTCHIP) and National Highway Development Sector Investment Program (NHDSIP) with the funding assistance of Asian Development Bank through Multi-tranche Financing Facilities (MFF). The Hassanabdal – Havelian Expressway (E-35) is one of the sub-project under the NTCHIP and being implemented by the National Highway Authority. This E-35 project is divided into two phases. The phase-I divided into 3 packages<sup>1</sup> having a road length of 58.6 km with 80 m right of way (RoW).
2. ADB Safeguards Policy Statement (2009) requires preparation and implementation of “Land Acquisition and Resettlement Plans (LARP)” and validation from an independent monitoring consultant.
3. The Second External Monitoring for the implementation of LARP & CAP of Package-II of Hassanabdal-Havelian Expressway Project (E-35) has been prepared by the EM consultant<sup>2</sup> to validate the updated progress as of March 31, 2015.

### ES 2: Introduction to report

4. This is the follow-up External Monitoring Report (Jan- Mar, 2015) for the implementation of Land Acquisition and Resettlement Plan (LARP, Package II) and a Corrective Action Plan (CAP) of Package II of Hassanabdal – Havelian Expressway Project (E-35). The package-II covers a road distance of 19.2 km starting from the chainage 020+300 to 039+500 (entire section falls in Khyber Pakhtunkhwa - KPK province).
5. The report comprises two sections. The section I covers the ADB approved LARP of Package II with LARP implementation status as of March 31, 2015. The Section II covers a CAP (Package II) prepared by NHA and approved by ADB as part of LARP requiring its disclosure and internal/ external monitoring. The section II provides the status of implementation of CAP as of 31 Mar 2015.
6. More details regarding implementation and its validation have been presented below:

## **ES 2: Section I: LARP Impacts and Payments:**

**A. LARP Impacts:** The numerical details on LARP impacts with payable compensation and number of displaced persons (DPs) is presented below:

- i) **Land impacts:** This includes the acquisition of 412 acres of private land owned by 2,759 landowners (DPs), with an amount of Rs. 770.942 million payable to land owners (DPs).
- ii) **Non-land impacts:** These include a) 106 structures<sup>3</sup> owned by 106 DPs with a total amount of Rs. 129.977 million payable to the DPs (b) a cropped area of 305 acres owned by 801 crop owners (DPs) with an amount of Rs. 20.14 million payable to the DPs and (c) a total of 988 trees<sup>4</sup> (comprising 359 fruit trees and 629 of non-fruit and wood trees) owned by 143 tree owners (DPs) with a total amount of Rs. 9.501 million payable to the DPs.
- iii) **Allowances under rehabilitation/ livelihood restoration<sup>5</sup>** - A total of 260 DPs are entitled to a combination of vulnerability, and livelihood and rehabilitation allowances with a total payable amount of Rs. 19.488 million.

### **B. Status of payments:**

- i) **Land payment:** In case of land compensation, 3,933 landowners<sup>6</sup> had to be paid an amount of Rs. 770.942 million. To date 2,970 landowners (75.5% of total landowners) have been paid an amount of Rs. 757.092 million. The remaining 963 land owners (24.5% of total landowners) are yet to be paid an amount of Rs. 13.850 million. Reasons for remaining payment and efforts made by NHA to complete the payment are explained in section ES-4 and ES-5 respectively.
- ii) **Non-land based payment<sup>7</sup>:** In case of non-land based payments, 1,425 DPs had to be paid an amount of Rs. 147.381 million. To date 1,065 DPs (74.7% of total DPs) have been paid an amount of Rs. 145.103 million. The remaining 360 DPs (25.3% of total DPs) are yet to be paid an amount of Rs. 2.271 million. Reasons for remaining payment and efforts made to complete the payment are explained in section ES-4 and ES-5 respectively.
- iii) **Allowances and rehabilitation/ livelihood restoration** - total 260 DPs are entitled for amounting to Rs. 19.488 million. Out of total, 257 DPs have been paid an amount of Rs. 19.373 million on account of allowances/ livelihood restoration, while the payment of remaining 3 DPs (Rs. 0.115 million) are under process.

### **ES 3: Section-II: Implementation of CAP of Package-II**

#### **A. CAP: Actions and Implementation Status**

8. The Corrective Action Plan (CAP) was prepared for package II of Hassanabdal – Havelian Expressway project in district Haripur of Khyber Pakhtunkhwa with the objective to ensure that land acquisition and compensation and rehabilitation and resettlement provisions and allowances provided in updated LARF and LARP fully comply with ADB's SPS as well as Pakistan's LAA, and where there gaps in compensation, adequate provisions for supplementary compensation, assistance and other gap filling measures have been made to ensure compliance with SPS's requirement of full replacement cost for all assets acquired for the project.

9. The policy requires that the CAP<sup>8</sup> is disclosed and fully implemented before startup of any civil works/ engineering activities. The EMA monitored the implementation of the CAP and validates that National Highway Authority (E-35 project execution Agency-EA) has disclosed the CAP (ADB and NHA websites) and continues to implement the actions provided in the CAP. Full

implementation of CAP will be validated before handing over the right of way for construction work.

10. The paragraphs below present the status of implementation of the CAP and its validation.

- Out of three packages, LARPs of package I and II have been approved by ADB. In case of Package III, LARP was required to be updated, which requires land valuation study to be carried out with its findings incorporated in the LARP in a manner ensuring payment of any additional compensation if the study concluded price differential. In this context, LARP has been updated considering the findings of land valuation study.
- The procurement process of Social Safeguard and Management Consultant (SSMC) has been completed and contract agreement has been signed on March 19, 2015.
- Disbursement of DPs compensation (land & non-land) at full replacement cost and allowances/ livelihood restoration as per entitlement matrix is at advance stage of completion as reflected in above section ES-2 and Table ES-A.
- In accordance with the linear map, the civil work has been commenced at reaches free from LAR impacts. However, non free LAR impacts area will be handed over to the Contractor on the fully implementation of LARP especially payments for lost assets and allowances.
- Grievance redress committee (GRC) has already been notified (Annex 4.4). However, there is no systemic redress set-up and record keeping of community complaints/ concerns associated with this project. A community complaint management register (CCMR) needs to be maintained at PIU, so that timely redress of community complaints could be ensured.
- As per ToR of EM Consultant, the reports, i) inception report, ii) external monitoring report (EMR) of package-II, iii) EMR of Package-I, iv) Second quarterly EMR of package-II, v) Second quarterly EMR of package-I have been prepared and accordingly submitted to NHA.

#### **ES4: Factors responsible for Delay in Payments**

11. The following reasons have been identified for delay in land and non-land payments as mentioned below:

- **Land compensation** - 963 are un-paid DPs due to following reasons and list is presented in Annex 3.1.
  - 665 DPs have small compensation amount or the compensation amount is less than that require for opening of bank accounts. These are termed as DPs with meager compensation amount. A proposed action plan is attached.

- 110 DPs do not live in project area or not traceable. NHA has made all possible efforts to contact such DPs but they are not still traceable, although the DPs may be living around the project area but PIU do not have any contact details of the DPs.
- 98 DPs have issues relating to land ownership/ title issues and cannot be paid unless the land transferred to their names;
- 12 DPs are contesting in the court for compensation enhancement;
- 78 DPs have different issues, i.e., 76 cases have some calculations errors in khasra (records), while 2 DPs have mortgage cases. Local revenue staff is checking the figures and after that, payment to all these 76 DPs will be made. A proposed action plan is provided.
- **Non-land payments** - 360 un-paid DPs
  - 360 un-paid DPs include 315 DPs of crop compensation, 45 DPs of trees compensation; the payment is under process.
- **Allowances/ livelihood restoration** - 3 unpaid DPs
  - 3 unpaid DPs (3 vulnerable allowances) - payment is under process.

#### **ES5: Efforts made by NHA to ensure all Payments**

12. NHA is committed to make payment to all the DPs and has made all good faith efforts, which include the following:

- Information disclosure was completed by disclosing the LARP related information to all DPs.
- Public notices were issued to the DPs, whose availability is discrete, inviting DPs to come and claim their compensation.
- Unpaid amount of compensation/ funds have been put in project account and DPs with their whereabouts unknown informed through a local newspaper (the daily “*Shamal*”) to come and receive their compensation.
- Information regarding early collection of compensation was also displayed through “*Banners*” at prominent places in all concerned villages.
- Project management (PIU) planned to make “cash payment” to the DPs at site who have meager amounts of compensation/ allowances. In this context, an approval has already been accorded from competent authority of NHA.
- Consultative process with DPs continued to make the payments to the balance number of DPs.

#### **ES6: Conclusions**

13. Hence, the report confirms that the LARP and CAP implementation covering cash compensation for land & non-land impacts and allowances<sup>9</sup> covering vulnerability and livelihood

restoration and rehabilitation aspects is at advance stage of completion. A continuous monitoring is required to ensure the implementation of LARP and CAP; and any implementation issue could be timely addressed.

14. **Substantial progress on land and non-land compensation:** The above progress reflects that 75% DPs (2,970 Nos) and 74% DPs (1,065 Nos) have received their land and non-land compensation respectively. This second quarterly EM report reveals that on the whole, 359 DPs received their payment belonging to different categories of impacts during the Quarter (Jan – Mar, 2015). Out of which, 131 DPs have received their payments of land compensation, while 201 DPs and 27 DPs received their non-land payments (crops & trees) and allowances/ livelihood restoration respectively.

15. The number of DPs by category of impact who received payment during the quarter (Jan. - Mar., 2015) is depicted in table below.

16. The compensation disbursement process is ongoing with all payable amounts (land, non-land items and allowances) available with NHA and Government treasury for payments to the DPs. Efforts are being continuously made to complete the payment of, a) remaining 963 DPs of land, b) 360 DPs of non-land and c) allowances of 3 DPs. This progress will be validated during the forth coming semi-annual report (i.e. 30<sup>th</sup> June, 2015).

17. **Rehabilitation Assistance & Livelihood Restoration Allowances:** the progress reflects that compensation of allowances/ livelihood restoration has been paid to 257 out of 260 DPs. The payment to remaining 3 DPs is in progress and will be completed by 30-Jun-2015.

18. NHA has made all necessary good faith efforts as mentioned above to make all disbursement of compensation to the entitled DPs. In this context, balance amount of land compensation has already been deposited in the District Treasury and remaining DPs can collect their entitled compensation any time. In case of non-land compensation, funds are available in the Project account and payment will be made as and when claims submitted by the remaining DPs.

19. It is also indicated that land has been transferred (mutated) to NHA; however, the clearance of right of way is in process.

20. **Status of Progress during the Quarter:** the progress during the quarter reflected in table s that land compensation of allowances/ livelihood restoration has been paid to 257 out of 260 DPs. The payment to remaining 3 DPs is in progress and will be completed by 30-Jun-2015.

### ES7: Recommendations

21. Considering the status of implementation of LARP and CAP of Package-II, the recommendations forwarded are as below:

- i) NHA efforts must continue and monitored till all DPs are fully compensated<sup>10</sup> to comply with Principle 11 of SPS 2009.
- ii) The PIU's resettlement and social mobilization capacity will be adequate enough for efficient implementation of LARP and Corrective Action Plan (CAP) after mobilization of social safeguard and management consultants.
- iii) The grievance redress committee has been notified but this needs to be effectively functional to resolve community complaints/ issues both at field and project level. There is a need to maintain a community complaint management register (CCMR), so that timely redress of community complaints could be ensured. In this context, a sample template for mainating a community complaint register is as below.

- iv) Total length of package II road is 19.2 km. All types of payments payable to the DPs as per LARP have been completed in different subsections totaling about 18.3 kms. Out of which 18.125 km have already been cleared for construction activities as per first External Monitoring report, while the RoW of another 0.175 km is cleared for

construction work as per this second external monitoring report. However, the construction activities will remain on hold in the specified reaches (as identified in table below and in part B of linear map at Annex-A) totaling of 0.950 km until the payments are fully made and are validated. The payments in these subsections are in process; although the progress is slow due to the reasons of land ownership disputes, inheritance and compensation apportionment cases. Amounts payable will be known after the revenue department makes the apportionment. Other issues delaying the payments are meager amount of compensation awaiting opening of bank accounts by DPs and some DPs not available at their given addresses.

### Status of LAR Free and Impact Reaches at Package-II

**1. INTRODUCTION**

**1.1 Background**

1. National Highway Authority (NHA) is currently implementing the two major road sector projects that include National Highway Development Sector Investment Program (NHDSIP) and National Trade Corridor Highway Improvement Program (NTCHIP) with the financial assistance of Asian Development Bank through Multi-Tranche Financing facilities MFF-I and MFF-II. These sub-projects are subject to the social safeguard policy of ADB. The National Highway Authority (NHA) under the financial assistance of Asian Development Bank (ADB) is implementing E-35 (Expressway).

2. ADB Safeguards Policy Statement (2009) requires preparation and implementation of “Land Acquisition and Resettlement Plans (LARP)” and validation from an independent monitoring consultant.

3. NHA has engaged an external monitoring consultant on 21 July 2015. In accordance with the terms of reference (ToR), the EMA consultant has prepared the following reports and accordingly submitted to NHA:

- An Inception Report/ 1<sup>st</sup> report was prepared in September 2014 covering approach & methodology; and workplan for conducting the quarterly & semi-annual external monitoring reports.
- External Monitoring of LARP and CAP of Package II of Hassanabdal - Havelian Expressway Project (December, 2014) as Quarterly Report No. 2
- External Monitoring of LARP of Package-I of Hassanabdal - Havelian Expressway Project (December, 2014) as Quarterly Report No. 3
- NHA has submitted these reports to ADB and accordingly ADB has approved the EMR of Package-II & I.

5. The Second External Monitoring for the implementation of LARP & CAP of Package-II of Hassanabdal-Havelian Expressway Project (E-35) has been prepared<sup>12</sup> to validate the updated progress as of March 31, 2015.

## 1.2 Project Description

6. The Government of Pakistan (GoP) is concentrating on the development of road infrastructure and its major emphasis is on the construction of new motorways/ expressways and improvement of the efficiency of existing roads from single to dual carriageways. The construction of Hassanabdal to Havelian Expressway (E-35) is an effort towards this objective.

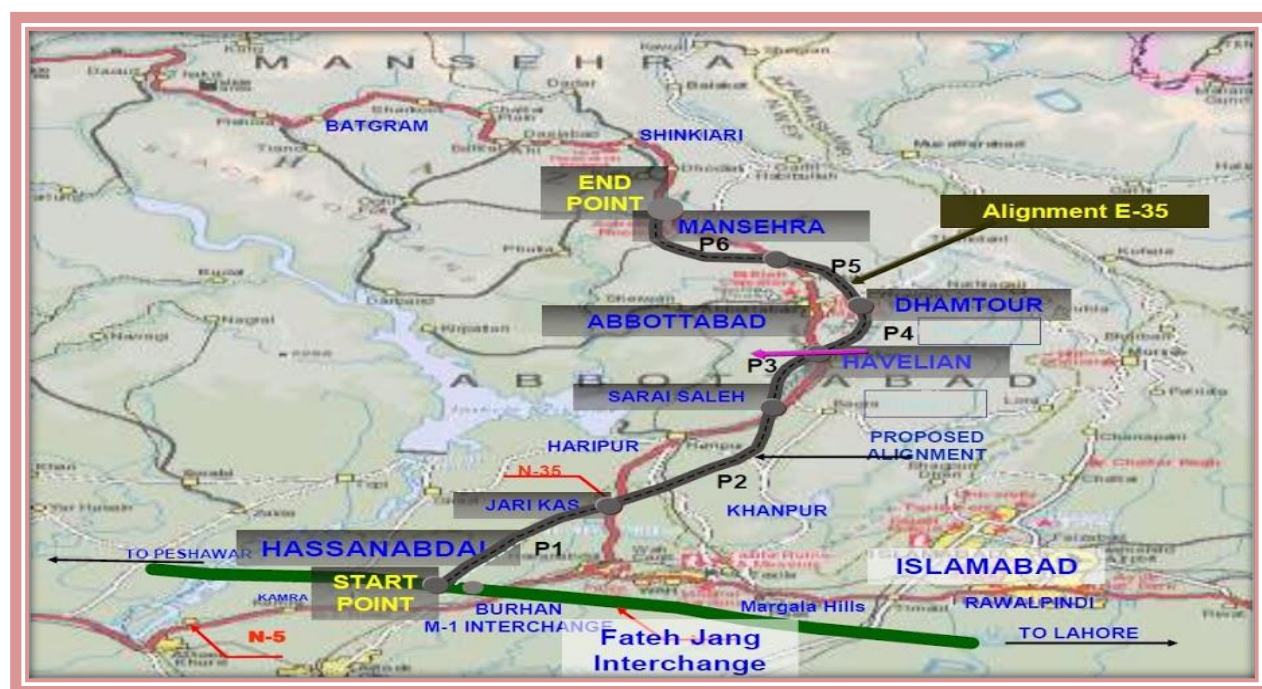
7. The E-35 Project is divided into two phases. Phase-I consists of road portion from Hassanabdal to Havelian and Phase-II includes road portion from Havelian to Mansehra. The length of Phase-I is 58.6 km. The Right of Way (RoW) of the Expressway is 80 m.

Package-wise details are as below:

- Package -I: 000+000 - 007+000 – Punjab portion  
000+007 - 020+300 – KPK portion
- Package-II: 020+300 - 039+500 – KPK portion
- Package-III: 039+500 - 058+600 – KPK portion

8. The location map of the proposed project road alignment is presented in Figure 1.1.

## 1.3 Objectives of the External Monitoring

9. Monitoring is an integral part of resettlement process that entails monitoring of preparation and implementation of Land acquisition & Resettlement Plans (LARP) and as laid down in the ADB's SPS 2009.

10. In accordance with the ToR, the objective of the external M&E is to review implementation, as well as to assess and validate the i) achievement of resettlement objectives, ii) changes in living standards and livelihood and restoration of the economic and social base of the displaced persons (DPs), iii) the effectiveness, impact and sustainability of the proposed entitlements, iv) the need for further mitigation measures (if any), v) institutional arrangements and capacity to implement resettlement, and suggest recommendations and remedial measures/ time-based corrective action plan.

11. Thus, the external monitoring will enable the project management to make timely decisions on corrective measures needed to implement the LARP and CAP effectively, and learn strategic lessons for future policy formulation and planning.

## **2. METHODOLOGY**

### **2.1 General**

12. This section of the report covers the review of status of progress regarding implementation of LARP and CAP of Package-II as of 31 March 2015, review of project related documents, data collection in field surveys consisting of interviews, consultative meetings with DPs including women, physical verification; and review of institutional arrangements for LARP implementation and redressal of community complaints. In addition to field survey, consultative meetings were also held with the project management and staff involved in the implementation of LARP & CAP.

### **2.2 Consultative Meetings**

13. A number of meetings were held with the General Manager (E-35), Buhari, Project Director (E-35) and staff involved in implementation of LARP and CAP. Meetings were also held with the Land Acquisition Collector (LAC), Deputy Director (Land) and project engineering staff involved in various LAR activities, including status of payment, reasons for non-payment, status of redressal of community complaints and training/ capacity building).

### **2.3 Review of Project Documents**

14. The project documents, including resettlement framework, land acquisition and resettlement plan; internal monitoring reports, status of LAR implementation, ADB Aide Memoire and other relevant documents were reviewed. The official letters issued and other notifications relating to the LARP implementation were reviewed and provided as annexes for ready reference. Similarly, the list of community complaints and status of their redress was also reviewed, analyzed.

### **2.4 Consultations with DPs**

15. A series of consultations were made with the DPs/ local community to get their feedback/ concerns relating to the LARP implementation including payment of land compensation, and other payments (crops, trees, structures & assistance/ allowances).

### **2.5 Data Collection and Analysis**

16. Data from both PIU and field was collected, analysed and accordingly updated the results. The data collection, compilation and updation was completed during the the period of 25



Mar – 5 Apr, 2015, while it took a number of weeks for the preparation of linear map by the PIU by involving technical/ engineering staff and revenue staff. The filed survey under this report covered the status of LARP implementation of Package-II (i.e. 020+300 to 039+500) located in the jurisdiction of KPK province.

17. All collected data were inputted on the computer and accordingly the data was analyzed in order to derive tables. The results were presented in the format of count, sum, means, percentage and numbers.

### 3. IMPLEMENTATION STATUS OF LARP OF PACKAGE II

18. The payment of compensation has been made keeping in view the eligibility and entitlements in accordance with the approved LARP of Package-II. This report has covered the status of payment of compensation as of 31 March, 2015.

#### 3.1 Project Impacts as per LARP

19. As per approved LARP of Package-II, the total number of DPs was 2,850. The details regarding category of impact are summarized in Table 3.1.

#### 3.2 LARP Implementation Status

20. This EM report describes the status of payment of compensation to the eligible and entitled DPs of Package-II<sup>13</sup>.

##### 3.2.1 LARP Implementation Status of Package-II

###### 3.2.1.1 Land Compensation

21. Total number of DPs for land compensation was 3,933 instead of figures given in LARP (2,759 DPs. Thus, the land compensation, 3,933 landowners<sup>14</sup> had to be paid an amount of

Rs.770.942 million. To date 2,970 landowners (75.5% of total landowners) have been paid an amount of Rs.757.092 million. The remaining 963 land owners (24.5% of total landowners) are yet to be paid an amount of Rs. 13.850 million.

22. The payment of land compensation to remaining 963 (24.4%) is in progress (Table 3.2). A summary of results is given in Table 3.3. Furthermore, reasons were also identified in case of non-payment of 963 landowners (DPs), although disbursement of land compensation is continued.

### 3.2.1.2 Factors responsible for delay in Payments

23. Reasons were identified in case of delay in payments of land compensation, although the disbursement of compensation is still in progress.

24. Table 3.2 indicates that out of total (963 Nos.), 665 DPs have meagre amount of share, 98 DPs have issues relating to 'title/ ownership', 110 are absentees/ non-traceable, 12 are court cases for price enhancement, and 78 DPs have other issues (some errors in share calculations/ record). Local revenue staff is checking the figures and after that, payment to all these DPs will be made.

25. Above-mentioned reasons for delay in payment are explained as below:

- **Land compensation** - 963 are un-paid DPs due to following reasons and list is presented in Annex 3.1.
  - 665 DPs have small compensation amount or it is less than that require for opening of bank accounts. These are termed as DPs with meager compensation amount. A proposed action plan is attached.
  - 110 DPs do not live in project area or not traceable. NHA has made all efforts to contact such DPs but they are not still traceable, although the DPs might be living around the project area.
  - 98 DPs have issues related to land ownership/ title issues and cannot be paid unless the land transferred to their names;
  - 12 DPs are contesting in the court for compensation enhancement;
  - 78 DPs have different issues, i.e. 2 mortgage cases, while 76 cases have some calculations errors in khasra (records). Local revenue staff is checking the figures and after that, payment to all these 76 DPs will be made. A proposed action plan is provided.
- **Non-land payments** - 360 unpaid DPs
  - 360 un-paid DPs include 315 DPs of crop compensation, 45 DPs of trees compensation; the payment is under process.
- **Allowances/ Livelihood Restoration** - 3 unpaid DPs (3 vulnerable allowances) - payments are under process.

---

number of land owners (as of 15 dec 2014) as 3,933. This number is expected to change further as the land records of affected land owners are updated with compensation proportionment/inheretence finalized by revenue department upon necessary land ownership documentation made available to revenue department and land acquisition collector (LAC) by the affected land owner. This needs to be further monitored and validated in routine external monitoring reports till the LARPi s fully implemented.

### 3.2.1.3 Crop Compensation

26. Total 1,059 crop owners had to be paid an amount of Rs.7.423 million. To date 744 crop owners (70.3% of total crop owners) have been paid an amount of Rs. 5.683 million (76.5% of total amount). The remaining 315 crop owners (29.7% of total crop owners) are yet to be paid an amount of Rs. 1.740 million (23.4% of total amount). Details are given in Table 3.3. DP- wise status of crop compensation is given in Annex 3.2.

### 3.2.1.4 Compensation for Affected Structures

27. Of the total 106 DPs (owners of structures), the payment has been made to all DPs in Package-II. Details are given in Table 3.3.

### 3.2.1.5 Severity Allowance to the Vulnerable DPs

28. There are 169 vulnerable DPs, including 137 severely affected landowners, 26 employees and 6 residential structures owners), the payment of vulnerability allowance has been made to 166 DPs, while remaining 3 DPs are under process. The payment to remaining 3 DPs will be completed by 30-Jun-2015.

### 3.2.1.6 Payment of Other Allowances

29. As per LARP of Package-II, there are 91 DPs, who are entitled for other allowances including livelihood, business/ transition, transportation/ shifting, house rent & electricity. Out of total 91 DPs, these allowances have been paid to all 91 DPs. Details are presented in Table 3.3.

### 3.2.1.7 Trees Compensation

30. In case of compensation for affected trees, 260 trees owners had to be paid an amount of Rs.9.981 million. To date 215 tree owners (83% of total tree owners) have been paid an amount of Rs. 9.450 million (94% of total amount). The remaining 45 tree owners are yet to be paid (Table 3.3). DP-wise un-paid cases are presented in Annex 3.3.

#### **4. CONSULTATIVE MEETINGS**

31. The consultations were made with 45 DPs/ local community and the major feedback highlighted as under:

##### **4.1 Consultative Meetings with DPs**

32. In general, no serious issues were highlighted by the DPs/ local community. However, some minor concerns pointed out are as below:

- Price of land needs to be enhanced. In case context, about 12 land owners have entered their reference in the court.
- Owners of structures were well satisfied with payments made as all structure owners have received their entitled payments.
- In village Chachain, local community was of the view that NHA may provide safety structures (wall/ retention wall).
- Most of remaining DPs have meager amount of payments, that is why they are not much interested to receive their payments
- NHA to facilitate in the processing of claims for the revenue department
- NHA staff cooperation regarding payment of compensation is appreciated
- People need access road to nearby village wherever necessary along the proposed road alignment

##### Women Issues

During the consultations with women, the female enumerators' highlighted the following concerns of the local women:

- Income generation activities for women in the area may be explored and accordingly some trainings (skill enhancement) may be organized and provided to local women.
- Copies of information disclosure should also be provided to the titled women.
- Women routine activities should not be disturbed especially during the construction stage such as work in farm fields, school teachers' mobility, privacy concerns, local mobility etc.
- Some appropriate jobs (office job) may be provided to the local women (especially DPs households) depending upon the education/ skill, which may be a contributory factor towards the household's livelihood.

##### **a) Redress of Issues**

- Some cases have been entered in the court, which are relating to the price

enhancement in case of land compensation. In this context, a number of hearings have been taken place upto 31 Mar 2015.

- NHA will facilitate the DPs/ local community regarding implementation of LAR activities and payment of compensation from revenue department and office of the Project Director.
- NHA has planned to make the payment in cash at site/ respective village as there are many payments having a meager amount especially in case of non-land impacts.

#### Women Issues

- Eligible and entitled women will be paid in accordance with LARF & LARP and CAP.
- NHA may allocate some funds for skill enhancement training of women, so that they can be involved in income generation activities to improve their livelihood.
- Some women preferably belonging to the DPs will be employed in the project-related job particularly in office work.
- Some conveyance facility may be arranged for some elderly women.

## 4.2 Information Disclosure

34. The objective was to inform the DPs/ locals regarding entitled compensation and livelihood allowances and other related concerns regarding the modalities of implementation of the compensation and livelihood allowances. The Information brochure/ pamphlet (translated in local language, i.e. Urdu) have already been distributed among affected persons. The information brochure summarizing the provisions of the LARP have been given to the DPs whose land, trees, crops or other assets and incomes are affected by the proposed road project. A copy of Information Disclosure is presented in Annex 4.1.

35. In addition to above, information was also published in local newspaper that the un-paid DPs can receive their entitled compensation of land and other non-land affected items. The notices/ advertisement & banners have also been displayed in each village, so that all un-paid DPs may receive their compensation and other entitled allowances.

36. In this context, a copy of advertisement given in a local newspaper (the Daily Shamal) and a “*banner*” is presented in Annex 4.2 and 4.3 respectively.

## 4.3 Efforts made to Ensure All Payments

37. NHA is committed to make payment to all the DPs and has made all good faith efforts, which include the following actions:

- Information disclosure have been made to all DPs;
- Consultative process with DPs continued to ensure that payments to be made as and when the DPs come forward to claim the payments;
- Public notices have been issued to the DPs, whose availability is discrete, inviting DPs to come and claim their compensation.

Unpaid compensation amount/ funds have been put in project account and DPs with their whereabouts unknown informed through a local (the daily newspaper “*Shamal*”) to come and receive their compensation. A copy of notice published in newspaper is given in Annex 4.2.

- Information regarding early collection of compensation was also displayed through “*Banners*” at prominent places in all concerned villages (Annex 4.3).

- Project management (PIU) has planned to make “*cash payment*” at site to DPs who has meager amounts of compensation/ allowances. In this context, an approval has already been accorded from competent authority of NHA. (Annex 4.5)

## **5. INTERNAL MONITORING REPORT**

38. In accordance with the LARP, Internal Monitoring report (IMR) has been prepared by the PIU and accordingly submitted to ADB. Internal monitoring report needs to be improved by incorporating selected monitoring indicators regarding disbursement of compensation, number of up-paid DPs; balance amount of compensation, complaints resolution and monitoring & evaluation/ MIS and status/ or need of training of staff (if any).

39. In addition, existing and proposed institutional arrangements also need to be discussed in the report, so that the gaps in institutional arrangement for LARP implementation could be bridged. In case training provided to the project staff relating to the LARP implementation needs to be described including, description of training, category of staff attended training and adequacy of training.

## **6. GRIEVANCE REDRESS MECHANISM**

40. In accordance with the LARP, the Grievance Redress Committee (GRC) has been notified (Annex 4.4) headed by the Project Director (E-35) including Director (LM&IS), LAC and AD (Land) as the members of GRC.

41. The grievances are received and reported to the members of the GRC. GRC involved DPCs in the grievance redressal process. Due to lack of required staff (GR Specialist/ MIS), the records of complaints is not fully maintained.

42. Most of the complaints received were relating to the assessment of prices by the revenue authorities. Accordingly, 12 DPs have entered their reference in the court for price enhancement and the hearings are in progress.

43. There is need to maintain a Community Complaints Management Register (CCMR) at PIU for proper record management of complaints. The information on register needs to be maintained in such a way that to date status of complaints could be analyzed. Fortnightly or monthly GRC meetings are essential for review and timely redress of entered/ registered complaints.

## **7. STATUS OF THE IMPLEMENTATION CAPORRECTIVE ACTION PLAN**

44. The Corrective Action Plan (CAP) was prepared for package II of Hassanabdal – Havelian Expressway project in district Haripur of Khyber Pakhtunkhwa with the objective to ensure that land acquisition and compensation and rehabilitation and resettlement provisions and allowances provided fully comply with ADB's SPS as well as Pakistan's LAA, and where there gaps in compensation, adequate provisions for supplementary compensation, assistance and other gap filling measures have been made to ensure compliance with ADB SPS (2009) requirement of full replacement cost for all assets acquired for the project.

45. NHA will be responsible for full disclosure and implementation of CAP<sup>15</sup> before startup of any civil works activities subject to validation by external monitor. CAP needs to be implemented by the NHA in full compliance with ADB SPS before project site could be handed over for civil works.

46. The paragraphs below present the status of implementation of the CAP and its validation.

- Out of three packages, LARPs of package I and II have been approved by ADB, while in case of package III, LARP has been updated by NHA based on the land valuation study. The updated LARP is being submitted to ADB for review and approval.
- The procurement process of Social Safeguard and Management Consultants (SSMC) has been completed and contract agreement has been signed on March 19, 2015.
- Disbursement of DPs compensation (land & non-land) at full replacement cost and allowances/ livelihood restoration as per entitlement matrix is at advance stage of completion.
- The commencement of civil work has been initiated at various stretches where LARP has been fully implemented.
- Grievance redress committee (GRC) has already been notified (Annex 4.4). However, the GRC needs to be strengthened to ensure timely redress of community complaints.
- This is the second external monitoring report prepared by EM consultant for the implementation of ADB approved LARP of package –II.

## 8. INSTITUTIONAL ARRANGEMENTS FOR LARP IMPLEMENTATION

47. NHA has established a Project Implementation Unit (PIU) under the General Manager E-35 at Abbotabd. The PIU is headed by a Project Director and other staff includes Deputy Director (LM&IS), Assistant Director (Engineering), and Land Acquisition Collector (LAC) with support staff.

48. The PIU is currently inadequate resettlement and social mobilization capacity for efficient implementation of LARP and Corrective Action Plan (CAP), which needs to be strengthened through, a) insitutional strengthening of safeguard management as per provision made in CAP, b) providing necessary job specific tarining regarding implementation of LARP and Corrective Action Plan (CAP) and redress of community complaints. In this context, the procurement process of social safeguard and management consultants (SSMC) has been completed and contract agreement has been signed on March 19, 2015. Now, there will be adequate resettlement and social mobilization capacity for efficient implementation of LARP and Corrective Action Plan (CAP) of Package-II of E-35.

## 9. CONCLUSIONS AND RECOMMENDATIONS

### 9.1 Conclusions

49. Hence, the report confirms that the LARP and CAP implementation covering cash compensation for land & non-land impacts and allowances<sup>16</sup> covering vulnerability and livelihood restoration and rehabilitation aspects is at advance stage of completion. A continuous monitoring is required to ensure the implementation of LARP and CAP; and any implementation issue could be timely addressed.

50. **Substantial progress on land and non-land compensation:** The above progress reflects that 75% DPs (2,970 Nos) and 74% DPs (1,065 Nos) have received their land and non-land compensation respectively. . This second quarterly EM report reveals that on the whole, 359 DPs received their payment belonging to diffent categories of impacts during the Quarter (Jan – Mar, 2015). Out of which, 131 DPs have received their payments of land compensation, while 201 DPs and 27 DPs received their non-land payments (crops & trees) and allowances/ livelihood restoration respectively.

51. The number of DPs by category of impact who received payment during the quarter (Jan. - Mar., 2015) is depicted in Table 9.1.

52. The compensation disbursement process is ongoing with all payable amounts (land, non-land items and allowances) available with NHA and Government treasury for payments to the DPs. Efforts are being continuously made to complete the payment of, a) remaining 963 DPs of land, b) 360 DPs of non-land and c) allowances of 3 DPs. This progress will be validated by the EMA through semi-annual reports.

53. **Rehabilitation Assistance & Livelihood Restoration Allowances:** the progress reflects that compensation of allowances/ livelihood restoration has been paid to 257 out of 260 DPs. The payment to remaining 3 DPs is in progress and will be completed by 30-Jun-2015.

54. NHA has made all necessary good faith efforts as mentioned above to make all disbursement of compensation to the entitled DPs. In this context, balance amount of land compensation has already been deposited in the District Treasury and remaining DPs can collect their entitled compensation any time. In case of non-land compensation, funds are available in the Project account and payment will be made as and when claims submitted by the remaining DPs. It is also indicated that land has been transferred (mutated) to NHA; however, the clearance of right of way is in process.

## 9.2 Recommendations

55. Considering the status of implementation of LARP and CAP of Package-II, the recommendations forwarded are as below:

- i) NHA efforts must continue and monitored till all DPs are fully compensated<sup>17</sup> to comply with Principle 11 of SPS 2009.
- ii) The PIU's resettlement and social mobilization capacity will be adequate enough for efficient implementation of LARP and Corrective Action Plan (CAP) after mobilization of social safeguard and management consultants.
- iii) The grievance redress committee has been notified but this needs to be effectively functional to resolve community complaints/ issues both at field and project level. There is a need to maintain a community complaint management register (CCMR),

- i) Total length of package II road is 19.2 km. All types of payments payable to the DPs as per LARP have been completed in different subsections totaling about 18.3 kms. Out of which 18.125 km have already been cleared for construction activities as per first External Monitoring report, while the RoW of another 0.175 km is cleared for construction work as per this second external monitoring report. However, the construction activities will remain on hold in the specified reaches (as identified in table below and in part B of linear map at Annex-A) totaling of 0.950 km until the payments are fully made and are validated. The payments in these subsections are in process; although the progress is slow due to the reasons of land ownership disputes, inheritance and compensation apportionment cases. Amounts payable will be known after the revenue department makes the apportionment. Other issues delaying the payments are meager amount of compensation awaiting opening of bank accounts by DPs and some DPs not available at their given addresses. (Table 9.2)

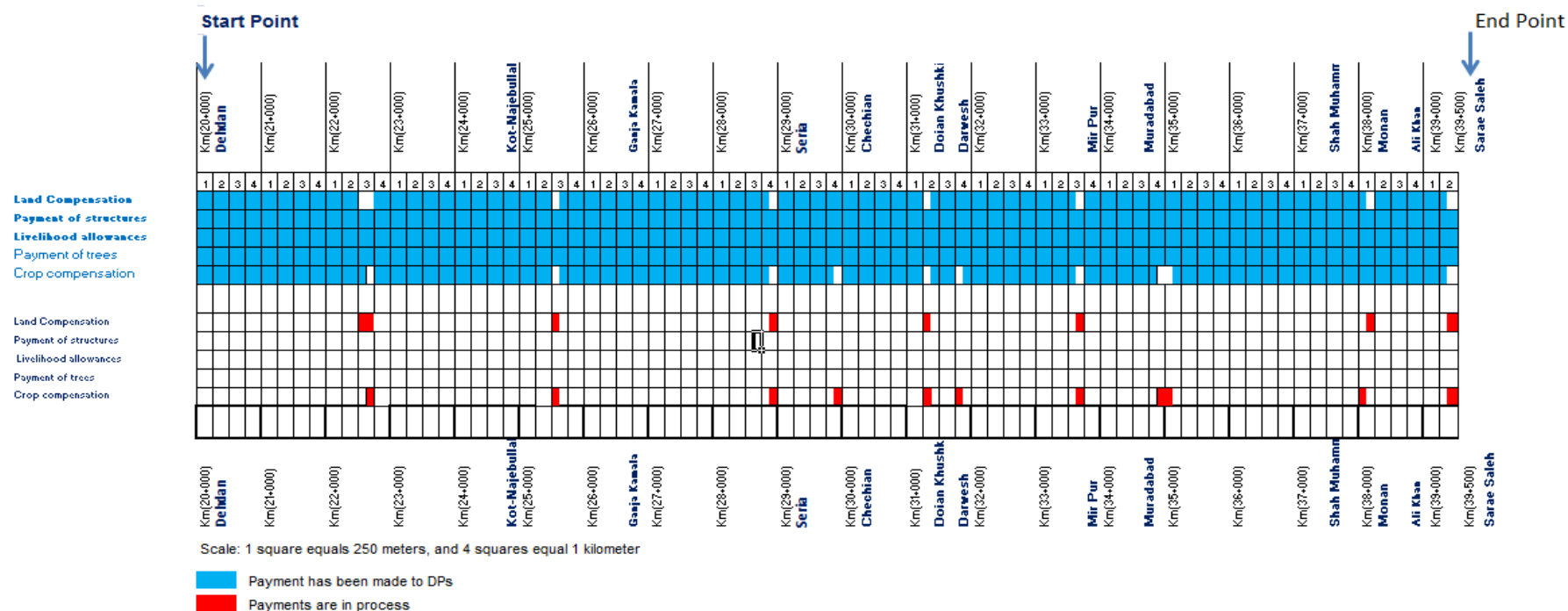

Amounts payable will be known after the revenue department makes the apportionment. Other issues delaying the payments are meager amount of compensation awaiting opening up of bank accounts by DPs and some DPs not available at their given addresses.

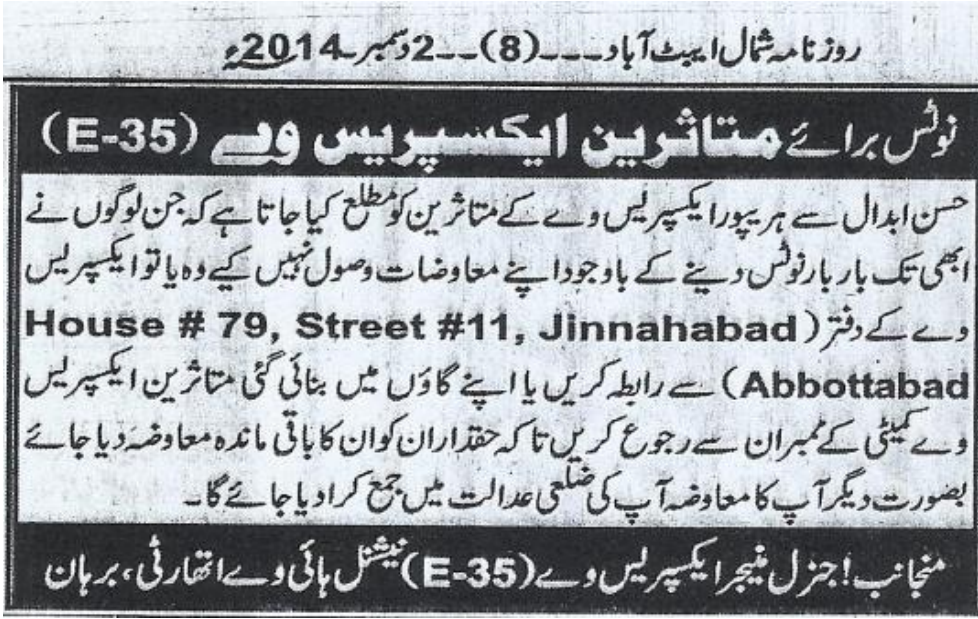
