## GENERAL PROCUREMENT NOTICE

1. The Federal Democratic Republic of Ethiopia has received a loan from the African Development Fund to finance the Drought Resilient and Sustainable Livelihoods Programme in the Horn of Africa: Ethiopia Project (DRSLP II).

2. The Drought Resilience and Sustainable Livelihoods Programme: Ethiopia Project (DRSLP II) is the second intervention in a long term Bank Programme to build communities' resilience to drought and Climate Change, improve their livelihood and promote regional integration in the Horn of Africa. The Program is a scaling up of the ongoing DRSLP I Project) in Ethiopia which covered 6 Woredas in Afar and 9 in Somali, whereas DRSLP II project will target 8 Woredas in Oromia and 7 in Southern Nations and Nationalities People's (SNNP). The Ministry of Agriculture (MoA) will be responsible for procurement activities under the project.

3. The project includes the following components: (i) **Natural Resources Management** (Water resource development, Sustainable land Management and Local conflict resolution mechanism) (ii) **Market Access and Trade** (Market support infrastructure and information system, Livestock market support and value chain and Mobility and trade and livestock products (iii) **Livelihoods support** (Livestock production and health, Food and Feed production and Livelihood diversification) (iv) **Project management and Capacity Building** (Capacity building and project management)

4 Procurement of Goods and works will be in accordance with the Bank's Rules and Procedures. Acquisition of the services of Consultants will follow the Bank's Rules and Procedures for the Use of Consultants. Bidding documents are expected to be available in **December, 2015**.

The Procurement modes are as follow:

- **International Competitive Bidding (ICB):** procurement of equipment for animal product quality control laboratory, equipment of Tsetse Suppression drugs and insecticides, equipment for regional laboratories and veterinary posts.
- **National Competitive Bidding (NCB):**
  - i) **Works:** Works such as water schemes (ponds, bore holes, spring development, shallow

wells), ; construction and rehabilitation of primary & secondary markets; upgrading the National Veterinary Institute, Regional Breeding Centres, Veterinary Clinics and Veterinary Posts

ii) **Goods:** Procurement of vehicles and motorcycles; drip irrigation materials; hand pumps; nursery hand tools; equipment for quarantine stations, hand tools for rangeland management; basic animal health tool kits, drought tolerant and high-value crop varieties, etc.

• **Shopping:** Procurement of nursery tools and fodder seeds, etc.

iii) **Consultancy Services:**

○ **Firms:** Baseline survey; feasibility studies and design for construction and rehabilitation of water supply infrastructures; supervision of construction and rehabilitation of water supply and other civil work infrastructures, supervision of construction/ rehabilitation works for feeder roads; and financial audit

○ **Individual Consultants:** Consultancy service for Monitoring and evaluation
