The project development objective (PDO) is to support Tanzania's economic growth by providing enhanced transport facilities that are reliable and cost effective, in line with MKUKUTA and the National Transport Policy and Strategy. Following are the key monitoring indicators for the achievement of the PDO: (i) reduction of rush hour travel time of public transport users in Dar es Salaam; (ii) reduced vehicle operating cost on the Korogwe to Same trunk road; and (iii) satisfactory rating of Zanzibar airport facilities by both airlines and passengers.

Implementation Status and Key Decisions

The Project remains on track to achieve its development objectives and the disbursement of the IDA Credit is 99 percent. The ratings for the progress towards the achievement of the project's development objective (PDO) remain moderately satisfactory (MS) but the rating for implementation progress (IP) is downgraded to Moderately Unsatisfactory (MU). The IP rating would be upgraded when the Governments start releasing funding to finance the shortfall on ongoing Bus Rapid Transit works contracts and decide on the way forward for preparation for BRT operators. The PDO indicators for Zanzibar airport component have already been successfully achieved while the progress on the Dar es Salaam Urban Transport is on track. The Zanzibar airport runway works were completed in August 2010 within the 15 months contract duration and to a good quality. The construction of the Bus Rapid Transit (BRT) infrastructure is about 90 percent completed. The works are expected to be completed by mid-November 2015. The additional cost overruns to be funded by the Government is on the ongoing BRT road works contracts and is mainly caused by the increase of workers' statutory minimum wages, extension of time to the contractor, variation orders and compensation for disruption which will be financed directly by the Government. While the competitive procurement process for the long-term BRT operator is planned to be launched soon, the Government has signed a contract with existing mini-bus operators to conduct interim operations. The modality of participation of the interim operators in the long term BRT operations is to be decided and included in the narratives of the long-term competitive procurement package before being issued to bidders.
