Implementation Status and Key Decisions

The World Bank Board of Directors approved the Project on June 23, 2015. The signing of the Financing Agreement is subject to the issuance of the Presidential resolution, which in turn is subject to the approval of the Feasibility Studies (FS) by the Cabinet of Ministers. The FSs for rehabilitation of project roads in the Tashkent oblast and Ferghana valley (Andijan, Fergahana and Namangan) were recently completed and are being processed for Government's approval. In parallel, preparation of project activities, including tendering of civil works in Tashkent oblast and development of TORs and specifications for the institutional strengthening activities are progressing. The Republican Road Fund - the implementing agency, has also advanced in implementation of the actions required for project effectiveness. The signing of the Financing Agreement and Project Effectiveness is expected to take place in July-August 2016.

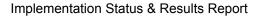




