

#### Implementation Status and Key Decisions

About the Project: The development objectives of the project are to expand access to water and energy services in targeted rural areas and to establish mechanisms to improve sustainability of service provision. The project comprises three components: (A) expansion of access to basic services in rural areas; (B) implementation support, supervision and monitoring & evaluation; (C) capacity building and sectoral technical assistance. The project will be implemented by the CN-TIPPEE, under the oversight of the Ministry of Energy and Water Resources (MERH).

<u>Project status</u>. The World Bank Board approved the project on September, 17 2015. The legal agreement has been signed on January 14th, 2016, and was sent to the Parliament for approval. Parliament has approved the project in June 2016, but the publication and legal opinion has not been issued but is needed to make the project effective. Meanwhile, the Government has been taking actions to ensure that all other necessary conditions are met by the reception of the legal opinion. In particular, the project implementation manual is finalized and just waiting for a formal approval by the Project's Steering Committee..

AFREA-funded studies. Given the complex and innovative nature of the project, a US\$ 1.3 million grant, from a World Bank Trust Fund (AFREA), was mobilized to fund a study aimed at assisting the GoG to develop, from scratch, an institutional framework for electricity and water services in rural areas. The AFREA-funded study (launched in December 2015) will facilitate the recruitment of an O&M operator, explore funding options, and assist in the preparation of the O&M financing framework. The two consultancy contracts have been extended to further assist the GoG to secure the funding and financing mechanism for the sustainability of the rural electricity and water services as well as to carry out more feasibility studies to prepare the subsequent infrastructure contracts.




