

Implementation Status and Key Decisions

Importance of the AFREA-funded studies. This is a complex and high-risk project, which basically helps the GoG to develop, from scratch, an institutional framework for electricity and water services in rural areas. The team has mobilized a US\$ 1.3 million trust fund to ensure that we can provide the necessary hands-on support to the GoG on this endeavor. The AFREA-funded studies (launched in December 2015) will facilitate the recruitment of an O&M operator, explore funding options, and assist in the preparation of the O&M financing framework.

<u>Project status</u>. The World Bank Board approved the project on September, 17 2015. The legal agreement have been signed on January 14th, 2016. Government has been taking actions to ensure that the project will be effective in the coming months. In particular, the minister in charge of Economy gave instructions to his team to immediately start preparing the ordonnance (in order not to delay the project with the parliament process) and committed to personally follow up the procedure with the President. The team expects project effectiveness in April 2016.

<u>Project Implementation Unit</u>. the PIU CNTIPPEE will be responsible of at least four projects starting in 2016. The TTLs of these projects have discussed the minimum set up of CN-TIPPEE to ensure a smooth implementation of every project. Key recruitments by each project have been identified and recruitment processes already started.

<u>Next steps</u>. The team plans to organize the next mission mid-March 2016, in between the team engages with Government counterparts and thetwo "AFREA" consultants frequently through regular audio/videoconferences.


