Loan No. 3096-PAK: Power Distribution Enhancement Investment Program – Tranche 4 — Amendment to Loan Agreement

- We refer to the Loan Agreement dated 30 April 2014 ("Loan Agreement") between the 1. Islamic Republic of Pakistan ("Borrower") and Asian Development Bank ("ADB") for the captioned project. All capitalized terms used but not defined herein shall have the meaning given thereto in the Loan Agreement, unless the context otherwise requires.
- Following a request from the Borrower dated 7 July 2015, ADB approved, on 25 August 2. 2015, changes in the scope of the Project and the allocation of the Loan proceeds. To give effect to the changes, ADB proposes that the Loan Agreement be amended as follows:
- In Schedule 1, paragraph 3, a new sub-paragraph shall be added at the end as (a) follows:
 - construction of up to 4 new 132 kilovolt grid stations and conversion of up to 2 existing 66 kilovolt grid stations to 132 kilovolt grid stations, along with their associated transmission lines."

The word "and" shall be deleted from the end of sub-paragraph (b) and inserted, instead, at the end of subparagraph (c).

The amendments shall take effect on the date of receipt by ADB of a fully signed original of this letter agreement.
