If the outputs are successfully delivered, the effectiveness of project design and execution will significantly improve, driven by the integration of evidence-based indicators and evaluability principles. Project teams will gain enhanced capacity to monitor, evaluate, and adapt their interventions, ensuring better results tracking and more informed decision-making.

Additionally, stakeholders will benefit from increased knowledge through the systematic analysis of lessons learned from past projects, enabling them to make adjustments to ongoing and future initiatives.

Finally, the dissemination of knowledge products and the implementation of capacity-building initiatives will accelerate the adoption of best practices, creating a more effective project portfolio.

Additional Information for consideration

One of the biggest knowledge gaps is whether programs that have lower impact than expected suffer due to problems in design (e.g., targets set too high) or during implementation (e.g., the executing agency changed the processes, thus affecting the outcome). The TC addresses knowledge gaps regarding best practices for project implementation and also gaps in information related to project impact and standardization of data.

By establishing best practices for project execution and standardizing indicators in a way that can be monitored with administrative data, the TC will foster better results for the portfolio. Having standardized indicators in the mid-term would also make project design easier and improve comparability between projects, making it possible to identify when a project is encountering issues during implementation. Having qualitative data on best practices allows projects to better understand how to implement the theory of change to attain results.
