

Implementation Status Overview

The National AIDS Control Program, Third Phase (NACP III) continues to make steady progress towards its goal to halt and reverse the HIV epidemic, by scaling up the coverage of targeted prevention interventions, and expanding integrated counseling and testing, anti retroviral therapy services, condom distribution and other activities. The official HIV estimates



for 2008-09 showed an overall reduction in adult HIV prevalence from 0.39% (2.6 million people living with HIV and AIDS, PLWHA) in 2004, to 0.31% (2.4 million PLWHA) in 2009. The estimated trends in HIV incidence shows a reduction of more than 50% over the past decade from about 0.27 million (2000) to 0.12 million (2009). Although the overall HIV prevalence rates among high risk groups are also declining, they remain high (2008-09): 9.2% among injecting drug users, 7.3% among men having sex with men and 4.9% among female sex workers. Preliminary data suggest that these rates have further declined (HIV Sentinel Surveillance) in 2010-11, although there are significant variations across states and within, which warrants scaling up of efforts to reach the hard to reach in these areas and to identify emerging hot spots, especially among injecting drug users, men who have sex with men and transgender groups. The targeted interventions (TI) have reached 81% of female sex workers (700,000), 66% of men having sex with men (274,000) and 71% of injecting drug users (126,000). ART services for adults increased by 30% between 2009-10 and 2010-11, and the estimated annual deaths from HIV have steadily declined from 199,502 (2006) to 172,041 (2009). An impact evaluation (2011) has shown progress in the decline of HIV among female sex workers, attributable to the program, and a cost effectiveness analysis (2011) estimates that 3 million HIV infections are being averted by the national program (by 2015) through targeted prevention interventions among female sex workers.


