Implementation Status and Key Decisions

Health Systems Strengthening and Ebola Preparedness Project (P147740)

Project effectiveness was declared as planned on March 16, 2015. Initial preparations for implementation are still ongoing, with particular attention to (a) preparing an Annual Work Plan and Budget for 2015 (6 months of implementation - now complete); (b) recruiting the key staff (mostly complete); (c) passing the necessary regulations to establish the key project committees and structures, and, (d) completing the Operational Manual and PBF manual. A formal project launch will be held shortly, as part of the next mission. Over 90% of the Ebola preparedness equipment and supplies have already been delivered by UNICEF and are being distributed.

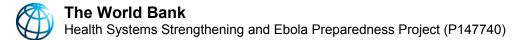
