As of June 2016, a total of 16,199 subproject proposals had been approved (of which 14,018 were approved during the 1st implementation cycle). As of end June 2016, a total of 10,994 SP had been completed. The WB team noted good progress in the roll-out of Cycle 2 Sub-Projects.
