## Implementation Status and Key Decisions

The TAME project became effective on 09 December 2015. After the grant recipient, Globe International Center (GIC), signed agreements with implementation partners All for Education (AFE) and Partnership for Transparency Fund Inc. (PTF), the first disbursement was completed on 09 March, 2015. Implementation activities for year 1 of the TAME project are on track as planned. As these activities are currently underway, it is too early to report on project impacts or results.

Specific intermediate outputs completed include: (1) Creation of a high-level Steering Committee, with membership from MES, MoF, and other

education sector partners; (2) Initial drafts of the Good School Assessment (GSA), the community scorecard, and questionnaires for the baseline survey. The baseline survey will measure outcomes prior to project rollout, and will be implemented in TAME project schools during the fall of 2015. The inception workshop to pilot the project's social accountability tools in soums and aimag centers is planned for winter of 2015.


