# Implementation Status and Key Decisions

The Transparency and Accountability in Mongolian Education (TAME) Project is financed by the Global Partnership for Social Accountability (GPSA) and administered by the World Bank. The project was restructured on 13 November 2015. The restructuring entailed (i) adjustments in the schedule of implementation of project activities, without a change in project closing date, so that project activities will be phased in during the first three years of the project; (ii) revision of the Results Framework and streamlining of disbursement conditions to support achievement of outputs that are most critical for the project's development objective (PDO).

Implementation activities for year 1 of the TAME project are on track as planned. As these activities are currently underway, it is too early to report on project impacts on outcomes or results. However, three intermediate outputs planned for year 1 that together constitute a first step to achievement of the PDO have been completed, and allow the team to recommend a PDO rating of satisfactory. These outputs are:

- 1. The Good School Support Tool (GSST), formerly the Good School Assessment, has been finalized. As the main tool that will be used by PTAs and other entities to monitor school performance and satisfaction with services and enhance transparency of school-level processes under component 1 of the project, this is a critical step forward for GIC. The baseline GSST survey has been completed at the 28 project schools, and data analysis is currently underway.
- 2. The Budget Watch Toolkit has been finalized. This is also an important development, as the Toolkit is the main tool that will be used by Civil Society Organizations (CSOs) to gather information on education budget and procurement processes at the aimag level, as a first step to enhancing transparency of these processes, under component 2 of the project. Selection of two CSOs to carry out component 2 activities in year 1 of the project is underway.
- 3. The inception seminar will take place on 14 December 2015, to launch training on and rollout of these social accountability instruments, and the format of the event, and its objectives and outputs, have been confirmed.

The upcoming inception seminar that will present findings from the baseline GSST survey will also present an opportunity to sensitize the Ministry of Education on benefits and use of information generated through project activities, and develop a shared understanding of how this can support the Ministry's education reform agenda. During the next supervision mission, the team will explore further ways to strengthen government engagement with the education sector accountability issues uncovered.
