Implementation Status and Key Decisions

Component 1: The project became effective on July 12th 2016. On August 5th the government submitted to the World Bank official documentations showing the achievement of DLI1 (retroactive) as well as sufficient level of spending on the Eligible Expenditure Program. On August 10th the World Bank issued the official confirmation of achievement of DLI1. The government submitted a withdrawal application on September 1st, and the first disbursement took place on September 8. Achievement of DLI2, 3, 4 and 5 is underway. The team expects the government to meet these within the indicative schedule.

Component 2: On August 31st the World Bank provided no objection to the Terms of Reference for the recruitment of key positions in the PIU (project coordinator, financial management specialist and procurement specialist). Recruitment of these positions is a withdrawal condition for Component 2. The government expects the recruitment process to take roughly eight weeks from the no objection.
