I. SUMMARY OF SUBPROJECT

- 1. The subproject (SP) "Lining Cham canal and management road of the South main canal under Nha Trinh Lam Cam irrigation system, Ninh Thuan Province" is implemented in Ninh Phuoc district, Ninh Thuan province. The SP is located in Ninh Phuoc district, and comprised of four (4) communes, namely: Phuoc Hau, Phuoc Thai, Phuoc Vinh and Phuoc Son.
- 2. Nha Trinh Lam Cam is a large irrigation system constructed over 100 years ago. The system's command area is 12,800 Ha, located in three districts of Ninh Thuan province, in which the South main canal has a total designed irrigation area of 6,800 ha and acanal length of 29kms.
- 3. Besides the upgrade and rehabilitation of the canal system, on-farm service road network is also rehabilitated and upgraded. The quality of the service road is poor and roads along the canal have a width of 3÷4m with fine texture soil surface. The ungraded soil of its base and surface causes landslide of the embankment to the canal's bed and its surface is also waterl ogged and muddy during the rainy season, which makes it difficult to transitthe road.
- 4. Cham Canal is a category 1 canal of the south main canal under Nha Trinh Lam Cam irrigation system. The Cham canal directly gets water from the South main canal at K4+500m,which currently hasa total length of 5.521kms. The Cham canal and branch canals are of category I and II and are natural (ungraded) earth canals. Out of the 50 kms of the total length of the canal system, only some canals of category II have some sections concrete lined such as Muong Chai (2.5kms), Muong Giang (542m), and Ho Tam (360m). The capacity of the Cham canal to supply water is quite high and water is abundant, potentially capable of meeting present and future demands for irrigation. However, due to its lenghtyuse, the effect of many floods and poor maintenance, the canal system is deformed, heavily sedimented its water conveyance capacity is severely reduced. Presently, only 1,500-2,000 Ha can be irrigated out of the total 2,800 ha of designed command area.
- 5. Canal and work items on the canal: All of the current canal routes are made of ungraded earth. The canal sides are mainly planted with bamboo, which limits visibility of transiting people. The water flow has a naturally carved curved shape;its operation and maintenance besidesits annual dredging are difficult because of lack of a proper management/service road. The cross section of the canal has expanded due to erosion and landslides. It is observed that water seepages occurall along the canal and on a permanent basis, lowering the efficiency of irrigation. There are 63 temporary structures on the canals made and maintained by thewater users. The canal crosses a newly-concreted inter-commune bridge.
- 6. Management road of the South main canal: the upgrading and rehabilitation of the South main canal includesservices roads along the canal 3 to 4m. wide, whose surface is made of fine texture soil. The canal road, aside from its use for irrigation purposes, also serves as a road which links Phuoc Hau, Phuoc Thai, Phuoc Vinh and Phuoc Son communes. During the annual harvest time, the canal road is the main road used by farmers in transporting their agricultural products to the markets. Since the road is only made of fine soiland was not hardly surfaced it has severely deteriorated by rains that are causing the surface becoming muddy and hardly transitable. Moreover, with the mechanization of agriculture in the subproject area, more farm equipment and other vehicles transit the road, contributing to its serious degradation.

II. RATIONAL AND METHODOLY OF DUE DILIGENCE ASSESSMENT

A. Rational of Due Diligence Assessment

- 7. Currently, advance payment on compensation and assistance to affected household of the subproject have been made and procedures for site clearance completed as recorded in its related REMDP being submitted to ADB for approval. At the time of conducting this Due Diligence, all households affected by the SP received compensation on the basis of policies of the Government of Vietnam and Ninh Thuan province.
- 8. Ninh Thuan PPMU has draft an official letter concerning the above advance payment for affected households for land acquisition as recorded in Annex 1.
- 9. The main purpose of this Subproject Resettlement and Ethnic Minority due diligence investigations is to find out what activities have been done for compensation and assistance to Ahs as well as procedure applied during DMS and payment, including information disclosure, consultation and participation of affected household in these procedure,including reporting of any inconsistency detected between the compensation plan and its implementation and the prescriptions contained in the uREMDF. Where inconsistencies are identified plans will be formulated for necessary amending.
- 10. This report summarizes the findings of these investigations and proposes solutions with related action-plans to ensure that the due payment of these supplementary entitlements to APs are implemented and meet the requirement of the uREMDF approved measures and ADB's policy.

B. Methodology

- 11. The following methods were applied in the preparation of this DDR: (i) collection of secondary data provided by the Ninh Thuan Provincial Project Management Unit (PPMU), and District Land fund development Center of Ninh Phuoc district (LFDC); (ii) discussions held with representatives of subproject communes on compensation and land acquisition activities, and (iii) interviews conducted with affected households (APs). Relevant details of the above are as follow:
 - Coordinate with local authorities and stakeholders (District and commune authorities and APs) to review the undertaking of information disclosure, delivers and receivers of information).
 - Review the redressing process following AP's complaints and present procedures applied.
 - Review and evaluate the impacts and income restoration strategy for severely affected households.
 - Interview representatives of LFDC about the DMS progress, compensation pricing and payment for APs etc.
 - Interview AHs who have already received compensation and assistance to get their feedback on compensation prices applied, assistance, participation of APs in compensation and resettlement, information disclosure modes to local people and local authorities etc.
 - Interview some APs who are regarded as severely Ahs, vulnerable groups such as female-headed households, ethnic minorities, poor APs etc.

- Compare the current resettlement policy with the approved uREMDF on compensation and resettlement, to analyze the differences between the implementation in the subproject and the approved uREMDF.
- 12. From May 4 to 7th 2016, LIC carried out surveys and interviews in four subproject communes, namely Phuoc Hau, Phuoc Thai, Phuoc Vinh and Phuoc Son and relevant agencies involved in the process, i.e., the Ninh Thuan PPMU and the Ninh Phuoc Land Fund Development Center. The main contents of the survey conducted focused on aspects like information disclosure, DMS process, compensation cost, land acquisition and compensation time, grievance and grievance's redress and compensation satisfaction as assessed by the APs.
- 13. Consultation with local authorities and affected household related to compensation and land acquisition activities have been conducted by each commune. Sample of minute of consultation meetings in Annex 3. Other minutes will be submitted as requested. Table below present the matrix of discussion with stakeholders:

III. SCOPE OF IMPACTS

16. Main impacts of subproject was identified by Detailed Measurement Survey (DMS) conducted in August 2015 by Land fund Development Center of Ninh Phuoc DPC, based on the approved investment subproject, including:

A. Permanent impact:

1. Affected households:

- 17. The subproject will impact on assets of 126 affected households/organizations consisting of 124 households (equal to 473 Aps with average HH size is 3.8 persons) and 02 organizations (Phuoc Hau and Phuoc Son CPC). Of the 124 affected households, 108 Ahs are affected on land and others assets, 16 Ahs are affected on crop and trees only. Out of 108 Ahs whose land was acquired, 48 Ahs (196 Aps) are severely affected (losing more than 10% of agriculture land). There is no relocated AH. Of 124 AHs, 08 HHs are ethnic minorities (07 Ethnic Ahs living in Phuoc Thai commune are Cham EM HHs and 01 AHs in Phuoc Vinh is Raclay EM HH) and the remaining Ahs (116) are Kinh ethnic majority.

2. Affected land

19. The SP "Lining Cham canal and management road of the South main canal under Nha Trinh - Lam Cam irrigation system" in 04 Communes of Ninh Phuoc District will permanently affect a total area of 99,427.5 m2. Of this 60,667.3 m2 is agricultural land, of which 54,496.9 m2 belongs to 108 households and 6,170.4 m2 is land of organizations: (Phuoc Hau and Phuoc Son CPC). The 38,760.2 m2 of the remaining affected land consists of irrigated land

20. Permanent agricultural land acquisition will have impacts on crops and trees of people in the subproject area. It is expected that a total of 45,749.25 m2 of annual crops owned by 97 AHs will be affected and that 63 AHs that own 7143 of affected perennial trees will lose these when construction work will commence. Most of the annual crop is rice; other crop include potato, onion and othervegetables. Affected fruit trees include banana, saboche, mango, guava, jack-fruit, melon, dragon, tamarind, apple, star apple, star fruit, rambutan, lemon, coco, avocado, papaya. Small area of annual crop land is grass for livestock. Affected perennial tree are Acacia, sung, nem, gao, bamboo. Table below summarizes the quantities of annual crops and trees by commune.

3. Affected houses and structures:

21. 13 types of structures of 31 AHs will be affected.

B. Temporary impacts

22. During construction, some lands will be temporarily acquired and rented as construction sites for worker camps, material storage etc. Likewise, there will be impacts to AHs along the road alignment. However, mitigation measures will be implemented to minimize the temporary negative impacts which are unavoidable, as civil works contracts shall include the following provisions: (i) contractor to pay rent for any land temporarily required for construction work; (ii) temporarily used land will be restored or improved by contractors to its pre-subproject condition before returning to AHs with confirmation of LIC.

IV. MAIN FINDINGS

A. Implementation procedures

23. Land acquisition and relevant implementation activities are summarized according to the timeline in table 9 below:

B. Implemented public consultation and information disclosure activities

- 24. Information disclosure and public consultation was organized by the local officials on a regular basis during subproject implementation from 2014 to date. All APs participated in DMS process and were consulted about the compensation plan as well as their entitlements.
- 25. The main information materials disseminated included: (i) General information about the subproject; (ii) The land acquisition needed for project implementation; (iii) The compensation and support policy to be applied; (iv) The declaration of DMS implementation plan in the field; (v) The compensation payment time; and (vi) The work construction time;
- 26. The information was disseminated via: (i) Meetings at communes; (ii) Loudspeakers of communes where land is to be acquired; (iii) Hand-over of documents, which consist of policy decisions on compensation, support and resettlement when the State acquisition land in Ninh Thuan province; and (iv) publicly posting the land acquisition notifications and compensation plans prescribed by the People's Committee of Ninh Thuan province.
- 27. The agencies/units in charge of the information dissemination were the LDFC and People's Committees of communes where the land is acquired.
- 28. On the basis of the land acquisition notification of Ninh Thuan Provincial People's Committee and the implementation plan for land acquisition, compensation, support and resettlement of subproject, the dissemination of information was conducted by LFDC and CPCs since June 2015.
- 29. During DDR assessment, consultation meeting was held for four communes and LFDC. The number of participants and their feedbacks is shown in table 10 below. Sample of minute of these meetings with the number of participants by gender and their feedbacks is presented in Annex 3. Other minutes will be presented when requested.
- 30. The results of discussions with LFDC, commune official and interviews with APs show that: all Aps agree with this subprojects as they understand the urgency of the construction schedule and accept the loss of one crop. Their expectation is that the subproject shouldbe soon constructed.
- 31. However, some APs claim that they are not clear of detail of the construction drawings and some difficulty inidentifying the border of land acquisition by wooden land acquisition marker. Some households ask for the acquisition to include the left-over land area that becomes inconvenient to be cultivated after part of it is taken away. Table below is summarizing the feedback of local people and authorities.

C. Resettlement policy framework applied for subproject:

32. The price for affected land was applied by Decision No. 4417/QD-UBND dated November 12th 2015 of Ninh Thuan PPC that regulate land price with adjustment factor for compensation upon land recovery by the State. According to this decision, the land cost applied for this subproject was equal to land price issued by the PPC for Ninh Phuoc district

- in 2015 (Decision No. 106/2014/QD-UBND, dated December 29th, 2014, applicable from 2015 -2019). The compensation rate for affected asset (houses and structures, plants and crops) was applied per Decision of Ninh Thuan PPC. Affected household agree with these compensation price.
- 33. The cut-off date for "Lining Cham Canal and Management Road of the Southern Main Canal, Nha Trinh Lam Cam irrigation system subproject" in Ninh Phuoc district, Ninh Thuan province is 30/6/2015; that is the date of the Decision for land acquisition for this sub-project issued by Ninh Phuoc DPC.
- 34. Regarding allowance, according to the uREMDF, depending on the level of impacts, the APs of SP could be entitled to receive the following allowances: (i) subsistence for severely AHs who lose 10% or more of agricultural production (ii) job changing/creation assistance in the event of agricultural land recovery by the State; (iii) assistance for vulnerable affected households. All AHs received compensation and allowances as per Ninh Thuan's policy (All Ahs received allowance for losing more than 30% agriculture land according to Ninh Thuan's plicy). Remaining allowances for AHs loss from 10% to 30% and for vulnerable Ahs have not been paid yet. Ninh Thuan PPMU drafted an official letter on the matter to DARD and DONRE to be submitted to PPC for approval. Each commune possesses minute recording the number of vulnerable households for any needed check.

D. Grievance and grievance redress

35. There was not a single complaint in writing; only 6 AHs (3 AHs in PHuoc Hau and 03 AHs in Phuoc Son commune) raised questions (verbally) to LFDC about missing out on some affected assets in the DMS and requested them to draft detailed compensation option to be publicly posted.

E. Preparation and approval of compensation plans

- 36. Compensation, support and resettlement plans for 4 communes of Ninh Phuoc districthave been prepared and found in accordance with the entitlements under the policy of the People's Committee of Ninh Thuan Province issued on the basis of Land Law 2003 and Decree 197/2004/ND-CP, Decree 84/2007/ND-CP, Decree 69/2009/ND-CP and Land Law 2013 and Decree 43/2014/ND-CP, Decree 44/2014/ND-CP, Decree 47/2014/ND-CP. The draft compensation plans were publicly posted for a period of 20 consecutive days at the office of the Commune People's Committees. The compensation plans were appraised by the LFDC and submitted to the Chairmen of the District People's Committees for approval.
- 37. By consulting Ninh Phuoc LFDC, Ninh Thuan PPC has instruction to relevant agencies for preparing new Decision on compensation, assistance and resettlement according to Land Law 2013. It is expected that new Decision will be approved by Ninh Thuan PPC on May 2016.
- 38. The working group assisting the LFDC made records on the public dissemination of plans, records of ending public posting and reports that summarize the comments from affected persons on the compensation made. The LFDC made a sum of questions of HHs to be solved and submittedit to the Appraisal Committees for the attention of the Chairman of the People's Committees of the District for approval of the compensation plans. When the compensation plans were approved, the LFDC, in collaboration with the People's Committees of the communes, posted copies of the compensation plans for the public at the People's Committee Centers prior to the payment of compensation and other supports. The average period of publicly posting was 5 to 7 days.
- 39. The compensation, assistance and resettlement plan has fully computed the entitlements and rights following the policies of GoV and Ninh Thuan's PPC. The Unit Price of the compensation is appropriate and equivalent to the market price at the time of compensation; the

unit price of agricultural land was surveyed by Ninh Thuan's PPC for setting-upthe replacement costand issued a price index of land valid for a period of 05 years, effective from 01 January, 2015 and at the same time conducted the land appraisal that started in 2015 in accordance with the Decree 44/2014/NĐ-CP and Circular 36/2014/TT-BTC.

F. Payment of compensation:

- 40. So far the subproject has paid for the number of households affetced by land acquisition whose compensation plans were established according to PPC's policy. The LFDC of Ninh Phuoc District, in collaboration with the Commune People's Committees, organized the payment of compensation and support under the plans approved by the District People's Committees. The amount of compensations and allowances were paid at once for households included in the approved plans. The payment was carried out at the offices of the Commune People's Committees before the households handed-over the land for the subproject. The decisions on approving the compensation plans were publicly posted at the offices of the Commune People's Committees before compensations and allowances for affected households were paid. The households were informed about the time and place of compensation payment 3 to 7 days earlier.
- 41. Local people will have the right to monitor and provide their feedbacks on the construction of the sub-projects and the implementation of the REMDP. Representatives of AHs and beneficiaries join the Commune Supervisory Board (CSB) that was established for four communes to perform participatory monitoring of the implementation process.
- 42. According to uREMDF, the implementation of payment compensation and assistance to Ahs are still missing assistance for severely AHs losing from 10 to 30% of agriculture land and assistance for vulnerable AHs.

V. Gaps between uREMDF with implementation on compensation and assistance to AHs

- 43. The payment of compensation and assistance to AHs before REMDP approval does not compile with ADB's policy then this DDR is prepared;
- 44. Missing allowances to Ahs as prescribed in uREMDF, including (i) allowance for SAHs who lose 10% to 30% of agricultural production (ii) assistance for VAHs.

VI. Conclusions

- 45. Basically, land acquisition of this subproject is compliant with Ninh Thuan province policy as follow:
 - i) APs participated in the project information disclosure and public consultation;
 - ii) APs were consulted and involved in the process of land acquisition;
 - iii) All APs participated in DMS process and signed on its minutes;
 - iv) Draft detailed compensation plans were disclosed;
 - v) Complaints were promptly solved by LFDC / CPC;
 - vi) APs received compensation before the handing over site; and
 - vii) All of affected households are satisfied and accepted the compensation cost.
- 46. In line with some gaps of applied payment on compensation and assistance to AHs as compared with the uREMDF mention in chapter 5, remedial actions are requested to implement by LFDC of Ninh Phuoc DPC and to be monitored by Ninh Thuan PPMU, together with other actions that is found during consultation meetings. Detailed correct action plan is in the next

chapter. All requested correction action plan are reported the third quarter internal resettlement report by Ninh Thuan PPMU.

VII. Recommendations

- 47. In iine with some gaps of applied payment on compensation and assistance to AHs as compared with the uREMDF mention in para. 44, remedial action is requested to implement by LFDC of Ninh Phuoc DPC and to be monitored by Ninh Thuan PPMU, including:
 - i) Allowances are requested to pay to Ahs after REMDP approval and complete before August 30th 2016, including (i) allowance for SAHs who lose 10% to 30% of agricultural production (ii) assistance for VAHs;
 - ii) Arrange the budget for allowance for SAH who loss 10% to 30% of agricultural production is VND 126,000,000 (equivalent to USD 5,657.9) for 33 Ahs and budget for VAHs is VND 596,320,000 (equivalent to USD 26,776.9) for 37 VAHs;
- 48. Regarding to concerns/complaints of Ahs during consultation meeting, consist of (i) detail drawing; (ii) additional land acquisition after DMS; (iii) some affected asset was not measured (case of Ms. Dong in Phuoc Vinh commune for instance), PPMU is request to corporate with Ninh Phuoc LFDC and communes to re-public drawings in each commune during July 2016, and recheck the additional area as well as affected assets are missing in DMS then revise the compensation plan for those AHs accordingly. Any additional affected asset after checking will be paid to Ahs within one week after approval REMDP that is expected in June 2016.
- 49. In addition, other correction actions below are recommended to carry out and reported
 - iii) PPMU is requested to coordinate with CPCs to monitor the income restoration of severely affected household, especially with Ahs losing more than 70% of their productive land (02 Ahs in Phuoc Haul, and 02 Ahs in Phuoc Vinh commune);
 - iv) At the time of survey/interview with AHs, none of the Ahs registered for vocational training courses. However, PPMU is requested to coordinate with LFDC for reviewing the number of Ahs that requested to register for vocational training and to support them in borrowing the necessary money from Social Policy Bank (this is in particular the case of Mr. Can losing is more than 97% of his productive land)
 - PPMU is requested to corporate with LFDC to check the request of some households for their remaining land that is now not anymore viable for cultivation, after part of it was curtailed, is also acquired (LFDC's report that more than 20 Ahs are in this case);
 - vi) PPMU is requested that training to CSB that has been established in four communes for monitoring the construction to reduce the impacts to local people.

The Subproject of Upgrading the Cham canal and management road of the South primary canal of Nha Trinh - Lam Cam irrigation system under the Integrated Rural Development Sector Project in the Central Provinces was approved on 19 May, 2016 by Ninh Thuan PPC in accordance with Decision No. 1085/QD-UBND.

Currently, the subproject has been completed procedures of compensation and site clearance and being submitted RP to ADB for approval.

Because the Subproject has specific characteristics, is only constructed in the time of cutting off water (40 days) and delays production of Summer-Autumn crop, compensation and site clearance activity is determined as much importance for the Subproject. Basing on this situation, Ninh Thuan Provincial Party Committee and People's Committee have paid attention to directing construction activity to meet the construction progress, ensure quality, put the works into use soon to serve production of people in the subproject area and minimize damage due to drought and water cut off schedule for construction of works.

With the attention and direction as above, the Subproject is allowed to make an advance by PPC to conduct advance payment for affected households in the subproject area to hand over construction site, prepare seedling for production of next crop season and be proactive in clean water resource for living activities during the time of cutting off water for construction of works due to delaying Summer- Autumn crop while economic condition of people is much difficult due to long term drought.

When the Subproject is completed and put into use, it will supply stable water resource for production and living of people, prevent water loss, increase gravity irrigation area, being proactive in irrigation and drainage to contribute to improving living condition of people, reducing poverty and increasing development of society, economy as well as ecological environment in Phuoc Son, Phuoc Hau, Phuoc Thai and Phuoc Thuan communes. Ninh Phuoc district, Ninh Thuan province.

From the urgent reasons, PPMU has conducted advance payment for affected households in the subproject area when cutting off water for construction. After RP is approved by ADB, compensation plan and resettlement plan will be publicized and then compensation payment will be implemented in accordance with regulation.
