AUDITOR'S REPORT TO THE MANAGEMENT (AUDIT OPINION)

The Directorate General of Audit Works (Provincial) Lahore audited the accompanying financial statements for the financial year ended 30th June, 2016 pertaining to "Lower Bari Doab Canal Improvement Project (LBDCIP) ADB Loan No.2299-Pak & Additional Loan No.3351-Pak".

The preparation of financial statements is the responsibility of the management of the Project. The management prepared combined financial statement for both the loans. Audit is required to express an opinion based on the audit exercise on the accompanying financial statement.

The audit exercise was carried out in accordance with International Standards of Supreme Audit Institutions (ISSAI). These standards require to plan and perform the audit to obtain a reasonable assurance that the financial statements are free of material misstatements. This audit was based on test check basis and includes findings, evidence supporting the amounts and disclosures in the financial statements. This audit also includes assessment of the accounting principles used by the management in making financial statements. Professional exercise was conducted to provide reasonable basis for audit opinion.

The Management Policy is to prepare the accompanying financial statements in the format agreed between the Asian Development Bank and the Government of Pakistan as noted in the Minutes of Negotiations for the Loan, [on cash receipts and disbursement basis in which cash is recognized when received and expenses are recognized when paid].

In our opinion, **(A)** the aforementioned financial statements and appended notes that were also subject to audit, fairly present in all material respects, the financial position of the 'Lower Bari Doab Canal Improvement Project (LBDCIP) ADB Loan No.2299 Pak & Additional Loan No.3351-Pak' and results of its operations for the financial year ended 30th June, 2016, in conformity with cash basis International Public Sector Accounting Standards (IPSAS), **(B)** the management of the Project has utilized all proceeds of the loan withdrawn from the Asian Development Bank only for the purposes of the Project as agreed between the Asian Development Bank and Government of Pakistan in accordance with the Loan Agreement and no proceeds of the loan has been utilized for any other purposes.

In addition:

- a. (1) With respect to the statements of expenditures, adequate supporting documentation was maintained to support claims to the Asian Development Bank for reimbursement of expenditure incurred and (2) the whole expenditure incurred during the year under Loan No. 2299-Pak and Additional Loan No. 3351-Pak is eligible.

Notes for the Financial Statements
For the Year ended 30 June 2016

1. Reporting Entity

The financial statements are for Lower Bari Doab Canal Improvement Project. The financial statement encompasses the reporting entity as defined in the Financing Agreement between the Islamic Republic of Pakistan and the Asian Development bank. The financial Agreement was signed on June 22, 2007 for an amount of JPY25,637,827,000.00 equivalent to US \$ 217.8 Million. The project became effective from 27-08-2008 with the closing date of 30.09.2013. Later on it was extended up to 30.09.2016.

The original currency of Loan no. 2299-PAK then changed from JPY to USD in FY 2015-16 for its Balance amount USD 55,783,544 million with same closing date.

Later on another ADB Loan No. 3351-PAK (additional to Loan no. 2299-PAK) were signed on 14-Dec- 2014 with effective date 11-Jan-2016 Amounting to USD 26.570m. The Project is implemented through Irrigation Department, Government of Punjab.

Financing

The financing is made in the form of Credit based on Asian Development Bank terms, with a maturity of 25 years, including a grace period of 5 years. The Financing Agreement No is Credit Cr 2299-PAK and ADB Loan No. 3351-PAK (additional to Loan no. 2299-PAK) were signed with a maturity of 20 years, including a grace period of 5 years.

Responsible Agency

A primary responsibility for overall progress and management of the Additional Financing has been entrusted to Irrigation Department, Government of Punjab.

2. Certification by Project Management on Application of Funds

The Lower Bari Doab Canal Improvement project management certified that the funds have been applied/expenditure have been incurred for the purpose intended in the financing agreement.

3. Accounting Convention and Statement of Compliance

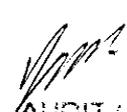
The financial statement have prepared in accordance with Cash Basis IPSAS Financing Reporting under the cash basis of Accounting.

4. Significant Accounting Policies

4.1 Foreign Currency Transaction

Cash receipts and payments arising from transactions in foreign currencies are recorded in Pak Rupee by applying to the foreign currency amount, the exchange rate between the Pak Rupee and the foreign currency at the date of the receipts and payments. Exchange differences arising on settlement of these transactions are recognized in the Statement of Receipts and Payments.

4.2 Reporting Currency

All amounts in the financial statements are in Pak Rupee.

4.3 Revenue Recognition

Revenue is recognized on the date of receipt of money by bank or clearance of cheque. Revenue is recognized on gross basis and any related costs are recorded separately.

4.4 Recognition of Expenditure

Expenditure is recognized on the date when payment is made or cheque is issued. Financial year to which the payments pertain is determined by the date on which a cheque or payment advice is issued.

4.5 Employee Terminal Benefits

Service benefits of Government deputations employees are accounted for in their respective departments while no service terminal benefits are paid to the contractual employees.

4.6 Payments by Third Party

The payments made by third parties do not constitute cash receipts or payments controlled by the Project but do benefit the Project as the Project does not receive cash (including cash equivalents) directly from, or gain control of the bank accounts or similar facility established for its benefit by, the third parties. Payments by third parties, if any, are disclosed in the Payments by third parties column on the face of Statement of Cash Receipts and Payments and notes to the financial.

5. External Assistance

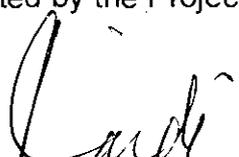
[ADB-financed projects in Pakistan are normally funded by two different sources. One is called Special Operations and one is Ordinary Operation]
