# Implementation Status and Key Decisions

This Project was approved by the Bank's Board of Directors on April 7, 2015, and countersigned by the GoA on September 21, 2015. It became effective on November 13, 2015, after the PIU furnished to the Bank acceptable evidence on the signature of an implementation support agreement between the client and UNDP, fulfilling in that way the conditions established in the loan agreement.

A National Executing Unit (NEU, or UEN) was integrated into the Environment Ministry line functions, by utilizing human capacity and systems established under a previous preparatory activity (P100806). The NEU, is in the process of being consolidated through the recruitment of new team members. Some progress has also been made towards the establishment of some of the Local Executing Units (LEUs or UELs) in the field. The recruitment of the UELs teams has been initiated, and the locations for the local offices have been identified.

The Project Implementation Unit (UEN + UELs) is currently adjusting the Project's Operational Manual, its Annual Operational Plan (POA), and promoting the signature of agreements with some of the Rural Development Agencies that will support the execution in the field.


