Following the project approval by the Bank on March 19, 2015, the Grant Agreement was signed on July 22, 2015 and was announced effective on the same date.

Ministry of Public Health is making good progress with preparatory activities for the project. Thus, the Project Management Unit was established and key staffing positions were filled, Project Operations Manual was completed; training activities on the Health Information System, clinical aspects of the Benefits Package, and grievance redress mechnism are underway. Fully fledged project implementation is pending issuance of the government decree.
