#### Implementation Status and Key Decisions

- 1. The project was approved by the Board on May 26, 2016. Since then, the Bank team has been working with the governments of the eight participating countries as well as the Regional Facilitation Unit (IUCEA Inter-University Council for East Africa) to get their legal agreements signed and help them meet the Effectiveness conditions. So far, IUCEA and six countries (Ethiopia, Kenya, Malawi, Mozambique, Rwanda, Tanzania) have signed the legal agreements, which leaves Uganda and Zambia pending for the completion of the signing. None of the participating countries as well as IUCEA has met the Effectiveness conditions yet.
- 2. IUCEA and the Bank teams have reviewed the Implementation Plans (IPs) submitted by the selected centers (ACEs) and provided comments for improvement. Each ACE is revising its IP and will submit the final version and have it ready for the signing of its Performance and Funding Agreement (PFA) with its government to meet the Effectiveness requirement.
- 3. A new Project Coordinator has been hired by IUCEA in early July 2016 who will be responsible for the coordination and administration of the project. The Bank team has provided orientation to the new hirer in understanding of the project and the operational requirements/expectations of Bank-financed projects.
- 4. The Project Operational Manual and the Project Communication Strategy are being further enhanced and finalized. They are expected to be ready for the project launching workshop.
- 5. The TOR for independent verification of results (DLIs/DLRs) was drafted by IUCEA and reviewed by the Bank team. IUCEA will finalize it and have it ready for advertisement once the implementation funds start to flow.
- 6. Due to the progress slower than what was anticipated by the Regional Steering Committee of the project, its annual meeting which will be combined with the project launching workshop has been postponed to the end of September or early October of 2016, depending upon how many participating countries can become effective for project implementation.
