RESOLVES:

- 1. That the President of the Inter-American Development Bank or such representative as he shall designate is authorized, in the name and on behalf of the Bank, as Administrator of the Multilateral Investment Fund, to enter into such agreements as may be necessary with Centro de Estudios Monetarios Latinoamericanos (CEMLA), and to take such additional measures as may be pertinent for the execution of the project proposal contained in document MIF/AT-1342 with respect to technical to promote an inclusive remittances market through improvements in the regulatory and legal framework and availability of data.
- 2. That up to the amount of US\$1,199,340 or its equivalent in other convertible currencies, shall be authorized for the purpose of this resolution, chargeable to the resources of the Multilateral Investment Fund.
 - 3. That the above-mentioned sum is to be provided on a nonreimbursable basis.
