
This Operation provides support to the Swachh Bharat Mission – Gramin (SBM-G) national program, the new rural sanitation flagship program launched by the Prime Minister in September, 2014. The Program Development Objective is to: *to reduce open defecation in rural areas, and strengthen MDWS capacity to manage the national SBM-G program*.

Implementation Status and Key Decisions

The Government of India launched the Swachh Bharat Mission ("Clean India Mission") to achieve universal sanitation coverage, improve cleanliness and eliminate open defecation in India by 2019. For rural areas, the mission is called the "Swachh Bharat Mission-Gramin" (SBM-G). The IBRD Operation (project) provides support to SBM-G. The objective of the Operation is to reduce open defecation in rural areas, and strengthen MDWS capacity to manage the national SBM-G program. To this end, the Operation supports two categories of activities, each using a different lending instrument: *Category1:* Performance incentives for sanitation improvement in rural areas (using Program for Results); and *Category2:* Technical assistance for strengthening institutional capacities on program management, advocacy, behavior change communications, and for independent third-party verification and improved monitoring and evaluation system to measure results of SBM-G (using Investment Project Financing). The Performance Incentive Grant system for States will be activated to reward states and their implementing agencies on their achieving and sustaining SBM-G results on reduction of open defecation, sustaining open defecation free status at the community level and increase in rural population with solid waste and liquid waste management. The operation is recently approved by the Cabinet and expected to be effective by May 2016. The Ministry of Drinking Water and Sanitation (MDWS) is the nodal Ministry and is responsible for the execution of the operation.

The first assessment will be done in Year 2.

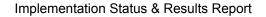

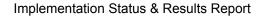
