Implementation Status and Key Decisions

After a slow start, the Victims Unit (VU) has made significant progress in implementing the project over the last 10 months. An acceleration of implementation has been especially noticed since a new project coordinator came on board (since March 2016), in addition to the full project team which had been in place since November 2015. With support of the project, the roadmap and framework for Collective Reparation is currently being reviewed by the Victims Unit. It is expected a revised framework will be finalized and validated internally and with other stakeholders by December 2016. Support for implementation of selected activities for 6 Collective Reparations Subjects (CRS) has been identified and prepared, including support for an ethnic CRS and a women association. A strategy to ensure lessons learnt from the implementation of these selected activities will be

captured to inform scaling-up, has been developed. An initial plan has also been developed for the development of a Monitoring and Information System for Collective Reparations. In addition, tools have developed for the implementation of the Collective Reparation Program, such as the tool for the detailed development of "medidas" from the approved Collective Reparation Plans.

Comments

The overall risk rating at project preparation was significant. The substantial risk rating was based on three main factors: (i) innovative nature of the technical design of the project, (ii) current limited institutional capacity to respond to the increasing demand for collective reparations, and (iii) limited fiduciary experience of implementation counterpart.

The risk remains substantial for the same three factors. On fiduciary aspects, while this remains challenging, with support from fiduciary colleagues, fiduciary performance has been moderately satisfactory to satisfactory.
