Status of Implementation Progress (Outputs, Activities, and Issues) IRC computation and ADB verification of compensation benefits completed for all sections. IRC house _to-house consultations started in November 2014 and were conducted following preparatory consultations with provincial officials and general group information sessions with AHs

All site improvement works based on the assessment report of site facilities have been completed. Operations and Maintenance (O&M) manuals in English and Khmer have been prepared. ADB has supported these O & M activities by providing consultants for community mobilization, O&M manual preparation, and training.

A study trip by IRC staff to Thailand was undertaken in February 2015 to learn about resettlement practices and policies. Two groups of IRC staff undertook a one week course on public engagement and conflict resolution in May and June 2015, under an ADB TA. A national consultant recruited by IRC continues to provide hands-on training to all staffs connected with GRM, through ongoing GRM cases.
