**Terms of Reference** 

#### Background

Latin America is the most urbanized region in the world; 77% of the population is urban, while in Asia, less than 40% of the population lives in cities and towns. In LAC, cities generate 55% of the regional GDP and it is expected that the 80% of future growth will originate in cities. Their role is key to the diffusion of innovations, knowledge generation and concentration of specialized labor force. However, 270 million poor people, the equivalent of 44% of LAC population, is concentrated in urban areas. This population has growing needs that in general are not currently satisfied by urban services. The multiple needs of its urban population represent one of the main challenges of the region for the next two decades.

LAC cities are called to make a critical contribution to sustainable development. However, most cities rely financially on contributions from central, regional and municipal governments. Financial resources are limited and it is necessary to develop new approaches to mobilize needed funds, to ensure quality of service and respond to changing needs and emerging issues.

Urban problems require an integral approach, combining the action of different sectors in the generation of complete and sustainable solutions.

The Inter-American Development Bank (IDB) is actively involved on urban development sector, mainly through the Fiscal and Municipal Management (FMM) Division of the Institutions for Development (IFD) Department.

FMM offers an innovative approach, combining fiscal and urban development tools with an integrated vision. It provides selective technical and financial support to LAC governments for i) improving the quality of fiscal and economic management at national and subnational level; (ii) improve the housing sector; (iii) promote the regeneration of inner cities and urban heritage and the integration of low income neighborhoods into the formal urban structure; (iv) fight urban poverty and promote social cohesion.

## **KEY RESPONSIBILITIES**

The Italian APO will provide support to the design and implementation of a range of activities carried out over FMM on sustainable urban development, particularly focusing on regeneration of inner cities and urban heritage.

- Support the design, execution and evaluation FMM's loan and technical cooperation. This will include preparing background studies; identifying data sources and data generation strategies for the collection, analysis, and dissemination of data and quantitative information in support of project design, monitoring and evaluation, as well as for the development of evidence-based policies.
- Contribute to the collection, dissemination, documentation and analysis of lessons learned, in the LAC Region and at the international level, and support its inclusion in Bank's new operation.
- Contribute to the development of networks in the promotion of inner cities and urban heritage regeneration.
- Contribute to the development of sector level knowledge by participating in meetings with experts, preparing and giving presentations, participating in working papers, technical notes and sharing information and analytical studies with peers.
- Prepare written reports and documents using Bank's formats on the analysis performed.
- Organize and participate to missions as required.

## **REQUIREMENTS**

**Education**: Post graduate degree in architecture and urban planning, economics, social studies.

**Experience**: At least two year working experience in either policy-making or project design and implementation or research (academia, research center, government agency, consultancy) on sustainable urban development and urban and cultural heritage preservation.

**Publication/Reporting track**: proven publication track on the theme (sectorial notes, papers and working papers, reports).

**Languages**: Full proficiency in at least two of IDB's official languages (English, Spanish, French, Portuguese), one being English or Spanish.
