Implementation Status and Key Decisions

The project was declared effective on July 2, 2015 and has started implementation. A first implementation support mission was fielded in September 2015 to support the launch of the project, and a second technical visit was completed in November 2015 to ensure that all operational and technical elements are in place for project implementation. Important project activities have started including the development of landscape management plans in the project areas for planning the productive safety net (PSNP) activities (component 1). Furthermore, the agreement between the Ministry of Health & Solidarity, the FADC and UNICEF for the implementation of the nutrition program (component 2) has been signed on December 18, 2015. UNICEF has now launched the competitive application process for key program staff, and a first disbursement request is expected in February 2016. Component 3 is already underway, focusing on strengthening the FADC management information system, establishing the monitoring capacity for the project, and designing an impact evaluation for the PSNP which is financed by a Bank grant provided by DIME.


