Implementation Status and Key Decisions

This ISR covers the main findings, recommendations and agreements reached during the Mid-term Review Mission which took place during May 30-June 3, 2016.

Implementation progress has been moderately satisfactory. Furthermore, the progress is unequal among components and entities with significant delays for certain subprojects.

Component 1, aimed at provision of emergency goods, has come to an end on December 31, 2015 and the actual distribution of goods will be completed by the end of 2016.

Component 2A, aimed at reconstruction of regional infrastructure, has shown some progress overall but with key challenges remaining for some subprojects. Component 2B, aimed at reconstruction of local infrastructure, has shown good progress overall. Most planned activities will be completed in 2016 in the FBiH, while in the RS, some of the subprojects will be delayed until 2017.

Component 3B, aimed at capacity building for disaster resilience, has not shown much progress for the FBiH and RS. The Bank will seek small grant funding for a Bank-executed technical assistance to support the Civil Protection Agencies in understanding the needs for disaster risk management for financing under the Project.

The progress towards the PDO remains satisfactory. Under Component 1, more than 100,000 people have already benefited from the replenishment of emergency goods destroyed during the floods, provision of agricultural support, support for housing and construction material, etc. Under Component 2, around 150,000 people have benefited from reconstructed critical infrastructure damaged by the floods.

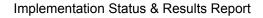

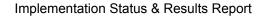

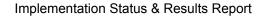

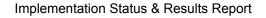

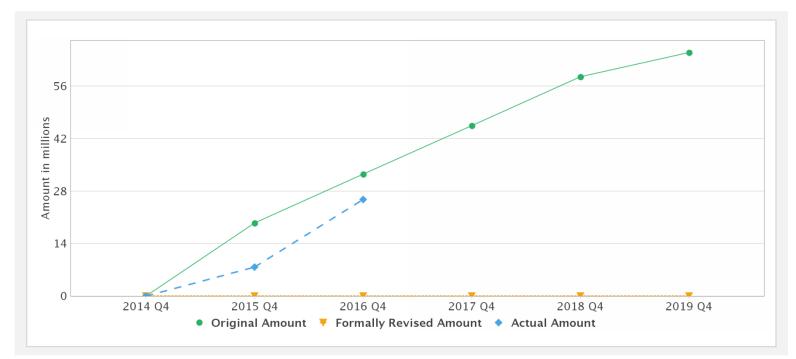
