




Implementation Status and Key Decisions

The project was signed on June 26, 2015 and is making good progress towards achieving its effectiveness conditions: 1) establishing a Project Coordination Unit (PCU), and 2) finalizing and adopting the Project Implementation Manual (PIM).

The project was approved by the World Bank Board of Executive Directors on May 20, 2015, and the Financing Agreement was signed between the Government of Guinea and The World Bank Group on June 26, 2015. The Government is currently working to ensure that the Financing Agreement becomes effective promptly and the project can be launched soon after.



Overall Comments

The baseline values have yet to be collected as planned. Given the unique situation in Guinea with Ebola during preparation, and the corresponding inability to collect reliable data, it was agreed upon during preparation to postpone baseline data collection to implementation. The establishment and hiring of the Project Coordination Unit (PCU), one of two effectiveness conditions, is making good progress. The PCU will include an M&E Specialist whose first task will be to obtain the required baseline data (which will also serve to determine end targets).




