Implementation Status and Key Decisions

Progress has been made towards establishment of systems and preparatory activities necessary for project implementation. Project Implementation Units (PIUs) have been established for all executing agencies (Mombasa and Kwale Counties, CDA, WRMA), and relevant induction processes conducted. The executing agencies have also prepared and commenced implementation of their annual work plans. Both the staffing structures and the work plans for all PIUs and the PMU will be reviewed during the next implementation support mission in May 2016.

During the last mission, it was agreed that the PMU and PIUs will prioritize key contracts that will lead to preparation of investments under the project. Consultancy services for preparation of designs and tender documents of these key contracts, including Mwache Dam, Mwache Check Dam and pilot irrigation, Kwale urban and rural water investments are all at technical evaluation stage. The contract for design review, preparation of tender documents and supervision of Mwache Dam construction is expected to be signed by end of May 2016. A dam safety panel of experts has been established to review the design and construction quality as well as other aspects related to dam safety, such as dam safety plans. As part of the WPA discussion, a draft system-wide economic and financial assessment of the Mwache dam and related investments has been completed. Preliminary estimates show that the overall system can be developed and operated on a self-sustained basis, including full recovery of the required loans, while maintaining the current Mombasa Water Company (MOWASCO) tariff, but with a slight increase of the bulk water tariff. However, this will only happen if MOWASCO turn-around plans are achieved.

Recruitment of a consultant to prepare a water master plan for Kwale county is at an advanced stage, and on rural sanitation, three consultancy services for providing support for implementation of rural sanitation activities were advertised in April 2016.

The Coast Development Authority (CDA) PIU is preparing the Mwache Catchment Management Plan (CMP) with support from the Water Resources Management Authority (WRMA) for the 2,250 km2 of the Mwache river catchment area, the long term strategies for the dam and sediment management. The CDA and Kwale County PIUs with support from WRMA will coordinate closely in their work planning and implementation to ensure full integration of related conservation and livelihoods activities through win-win solutions, and minimize duplications. The PMU and WRMA PIU will work together to harmonize the arrangements being made for the Mwache Dam watershed sub-component and developing a payment for environment services (PES) scheme to help with the long-term protection of the Mwache watershed.


