Implementation Status and Key Decisions

The Project was approved on September 29, 2015, signed on October 26, 2015 and declared effective on February 18, 2016. However, after six months into implementation, limited progress has been achieved in the implementation of agreed activities due to disbursement delays. Following the first disbursements in late June 2016, the Bank has encouraged the several teams implementing their respective components to accelerate the pace of implementation to ensure that some of the activities can be initiated before the upcoming rainy season.


