Dear mrs. La Valley,

The Ministry of Finance and Planning, as the representative of the Government of Suriname, wishes to request participation in a regional initiative funded through Technical Cooperation No. RG-T4461 "Violence Prevention in Schools: A Multidimensional Approach for the Caribbean" totaling Four Hundred Thousand United States Dollars (US\$400,000). The Inter-American Development Bank has successfully secured this funding to support Ministries of Education across the Caribbean, including Suriname.

The primary objective of Technical Cooperation (RG- T4461) is to address the critical issue of violence in schools, which significantly impacts student retention and safety. This initiative aims to design and implement a School-Based Violence Prevention Program tailored to the specific needs of Caribbean countries, focusing on students at high risk of dropping out. Specifically, Suriname would benefit from the following activities:

- Diagnostic of youth violence in the Caribbean: Conduct a thorough analysis of youth violence in participating countries to assess the main drivers of school violence in the participating countries.
- 2. **Documentation and Replication of Best Practices**: Documenting two existing flagship interventions in the Caribbean to share knowledge and best practices across the region.
- 3. **Regional Event**: Hosting a regional event to bring together a diverse group of stakeholders, and experts in violence prevention in the Caribbean. This regional event will serve as a platform for sharing experiences, building on collective knowledge, and learning from past mistakes.
- 4. **Design and Implementation of a Tailored Intervention**: Developing and piloting a school-based violence prevention program in selected schools in participating countries.

This communication serves to confirm Suriname's keen interest in benefiting from this regional initiative, which, by its nature, will be administered by the IDB.

We are hopeful for your favorable consideration of our request and earnestly seek the Bank's assistance in providing us with regular updates on the progress of implementing this Regional Technical Cooperation.
